# Government in business a smoke screen

*Empty treasury coffers desperately need cash*

Finance Minister Mark Brown's parroting of his Finance Secretary Richard Neves unqualified script Government has no purpose getting into commercial business is a sad indictment of his inept understanding of Government and private sector partnerships.

The Chinese Government has seen the value and experienced outstanding results from joint private sector engagements. Then again know all Neves can't see beyond his limited business knowledge and has done nothing but slowly reduce Brown to his basement level of business deficiency. Initially showing some promise of growing his business capacity through being the Minister of Finance, Mark Brown has regressed and become dependent on the incompetent Neves. Brown simply has the wrong coach and should detach himself from Neves and find himself a small group of business mentors whom he can bounce off ideas and policy components.

The cognitive distortion Brown is captive to is, if the Cook Islands exercised our first right to purchase Telecom New Zealand shares in Telecom Cook Islands the business would fail. How embarrassingly wrong. How Brown could look at his own face in the mirror without scolding himself is self preserving. TCI has been successfully run for years without the operational involvement of NZ or the politicians and has delivered at least \$20million in dividends over the last ten years.

Just as he was quick to open his mouth over opening the books of TCI after his successful election and appointment as Minister for Communications, Brown had to retract his over exuberant promises because contractual confidentiality prohibited public disclosure. Brown is having a similar thoughtless mouth opening moment with

reckless media statements that expose his knowledge void. To compare the government's purchase of TNZ shares with Toagate is ludicrous. Whatever possessed Brown to make such self incriminating babble needs to be exorcised immediately.

Brown needs to stand back take a deep breath then listen and hear the voice of the people independent of the more and more business incompetent Neves reveals to be. Instead of mouthing off Neves' prepared scripts, Brown ought to do a lot of listening and restrain himself from his silly dismissive off the cuff self incriminating comments.

Brown's shoot from the hip comments have and are devaluing hard working Cook Islanders who have tirelessly toiled to make TCI what it is today. Once owned by the British Cable and Wireless, after their controversial departure Cook Islanders have owned the results of their labours. TCI is a well run profitable company operated by highly trained and qualified local managers who could hold their own internationally. Take for example the former CEO Stu Davies, who learnt his craft at TCI, he was snapped up by an international organisation at the drop of the hat. Then there is Phil Henderson, Jeane Matenga and many others who did their time at TCI.

Last Friday TCI Board Chairman Temu Okotai met with a group at TCI at their request who shared their concerns of the lack of transparency and worries about their employment futures. As per normal those affected the most don't get consulted but informed after the deal is done.

Given the opportunity local management could step up to be CEO without a resulting glitch in the operations. To imply TCI would fail if the Cook Islands purchased TNZ shares is so far from reality. If anything the

locals who have invested their working lives in TCI would be so proud the company was 100% Cook Island owned and all will rise to the occasion to make the rest of us just as proud.

Part of Brown's sell out thinking has been shaped by the constant nit picking by disgruntled expats who have expectations beyond reality.

Like Neves, Brown is blinded to what locals can achieve given the genuine opportunity to do so. Backed by a Board appointed based upon competency instead of political patronising TCI will become a real flagship of local commitment. Get real Minister of Finance.

The Cook Islands should be grateful such talented locals have not absconded to greener pastures taking their highly in demand telecommunication skills with them. A Digicel buy out will without a doubt see a 30% cut in personnel, some at the high end. The outer islands TCI staff will also be negatively impacted. What do you say to these people and their families Mr Brown? We all know its water off a ducks back to Neves.

Hopefully the Chamber of Commerce delegation was able

to talk sense with Brown at their lengthy meeting last Friday.

Digicel want a monopoly grace period of five years and the money grabbing Neves the architect of Nenevanomics won't hesitate or blink an eye lid in giving it to them as long as he got his hands on the \$7 million to.

Te Aponga is 100 percent owned and it is self sustaining and commercially profitable and is overseen by a local Board and headed by Mangaian Apii Timoti. The Airport Authority has a local Board with Joe Ngamata at the helm and is commercially sustainable without receiving government funding.

So where is the sense in Brown's flippant comment that government should leave business to the private sector? TCI, Te Aponga and the Airport are successful commercial operations proudly headed by local people. What will be the difference with a fully locally owned TCI?

Get behind your local work force Brown or we'll end up with an influx of more expats and immigrant workers. Think local, go local or local go.

# Subtle changes to finance law and policy amount to social engineering

## *It's time to pause.... for a cuppa*

While it may not be noticeable now, the outcome will confirm what has been suspected all along, and that is, precise but subtle changes to finance laws and policy, will bring about fundamental changes to our society and pave the way for even more dramatic changes to come.

This process of change is so subtle as to be almost undetectable except to those who have experienced the process previously.

Unless some intervention occurs, it will be too late to halt this process of change and society will have to deal with the consequences.

What is happening in the finance sector amounts to social engineering and it is being driven by expatriates who lack cultural understanding and sensitivity and inexperienced theorists with no real depth of experience under a mistaken belief that tinkering with the economy to fit a foreign economic model will better adapt our society for the changes to come.

A small group within MFEM will have needed to sell the idea of a new economic model to the Minister of Finance and the PM. Other Cabinet Ministers need not know.

Raising VAT, means testing the local pension by making it subject to tax for the first time in our history, overturning a 17 year old no-tax policy on the NZ pension, removal of import levies thus knee capping local agricultural production, the introduction of user pays for water because an overseas

government demanded it and now the proposed sale of Telecom without public mandate, are major changes which will alter the way our society evolves. Government has failed in one important duty, and that is, to fully explain the reasons for and the implications of these changes.

We saw this social engineering in NZ during the time of "Rogernomics" when Finance Minister Roger Douglas and a Labour government de-regulated the finance sector and young, bright, theorists in Treasury with no practical experience began shaping government policy to the extent that whole towns and societies were affected. Imported goods became cheaper forcing some factories to close and jobs to be lost. Government ministries moved to a more business like footing and the speed of change took many by surprise.

In NZ, after Douglas proposed a "flat tax," it took PM David Lange's intervention, "Pause for a cuppa tea," is what he called it, to halt a rampant Finance Minister Roger Douglas and Treasury. Douglas had no option but to resign. Like Douglas, Cook Islands Finance Minister Mark Brown backs his Finance Ministry to the full. Finance Secretary Neves has been allowed free reign to shape laws and policy. On the issue of demanding a back tax on those receiving the NZ pension, Neves has challenged affected parties to take him to court. Yet Neves has never fully explained the

legal provisions that enable people's bank accounts to be raided. The public should not have to pay for that information. As a public servant, Neves must make that information freely available.

When the CIP came to power, it came with a healthy majority and as such the CIP could say the public had confidence in the party and that such confidence translated into a mandate to make changes. However, that majority has been eroded and now the CIP are finding it harder to convince the public to accept major changes to tax laws and policy.

Undermining public

confidence in the CIP is that the tax law and policy changes have not come up through the grass roots rank and file in the Punas and been thoroughly discussed and endorsed by conference.

It should be clear to government that the public are struggling to cope with, let alone comprehend, the magnitude, effect and pace of change. Worse, is that the public do not understand the reason for these changes.

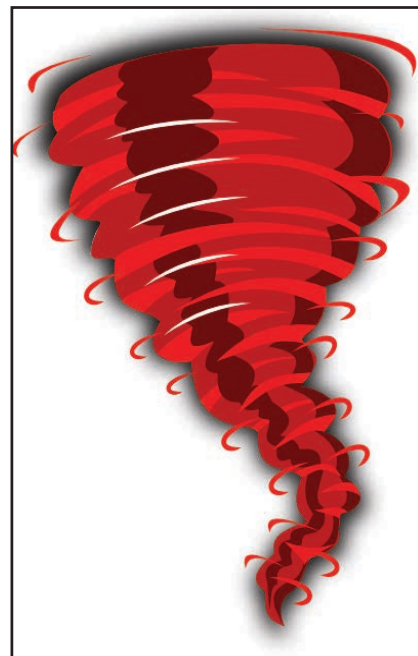
MFEM are setting the country up for a new economic model.

# Dingo culture barks politicians into submission

## *Richard Neves has no love of being a tail*

The readiness to cash up locally owned Telecom Cook Islands shares in a sell out to international Telco Digicel has nothing to do with the Cook Islands Party Government insisting they shouldn't be in business is moral fraud and more than misleading. The quick fire sale has everything to do with the country heading into a fiscal melt down stemming from the mismanagement of our sovereign financial responsibility by none other than the Ministry of Finance and Economic Management Richard Neves.

Lead by a novice team of leaders both lacking in hardnosed business acumen, the Prime Minister Henry Puna and Minister of Finance Mark Brown failed to recruit a small group of successful business advisors for brainstorming and guidance in matters of sovereign fiscal issues as did Sir Geoffrey Henry who balanced his occupational weaknesses through the strengths of others.

Unfortunate to be daily confronted with financial and economic challenges beyond his personal capacity and experiences Brown has leaned on Neves to the extreme. Credit to Brown, what would have crushed many others, he has so far survived one overpowering issue after another, but for how long?

A serious deficiency of the current Cabinet is they have been preoccupied with everything secondary defaulting their primary task of creating policies contextually with the National Constitution, the CIP Constitution and their campaign platforms. Secondary tasks have been Leadership's focus advocating their primary tasks to

the bureaucrats.

Elected to give the country direction and a working road map of prosperity to all the CIP government in the prolonged celebratory euphoria of returning to governance after a decade in the political wilderness have awoken to the reality the drinks have ran out and the music they face can be overcome if everyone in the vaka has a psyche of personal ownership. Lacking a vision that unifies and encompasses everyone in all the tribes leaving none out of the vaka the CIP Government head has surrendered its tasks and responsibilities to the tails.

Instead of acting decisively and delivering Cabinet's policies to the Ministries to implement and sustain the lazy CIP Government has been subordinated by their tails who have created policies of their own then imposed them on their Superiors.

Watchdogs, The Audit Office, Ombudsman, PERCA and the Public Service

Commissioner collect obese pay packets to little more than warm seats. No one would know if they were all closed and disbanded and no one would miss them.

How embarrassing for the Prime Minister Henry Puna to go on television and pour out his heart in an emotional speech assuring the raided Grey Power members their extracted Bank account savings would be reimbursed only for Neves to return from his Christmas holiday to nullify Puna's promise. So who is the head and who is the tail? How fitting it is that the Grey Power has called Puna the Great Pretender.

With Puna now firmly put in place by Neves, Mark Brown is now being transformed into the image Neves has purposed for him. Facing career ending consequences (Neves favourite mantra) Brown has been dingoed by the Aussie who is needing quick cash to stay solvent. Neves sees TCI as a cash cow to be fleeced. With no policy on national assets being rolled out by cabinet, tail come head Neves is creating one from fresh air, sell national assets.

The TCI Digicel by out saga is being fuelled by Neves and driven by Brown, both enthused about quickly wrapping up the deal for \$7 million. If Brown was to keep track of all his off the cuff unintelligent comments about Digicel's proposal he will realise he has exposed his shallow appreciation of the telecommunication industry. Every time Brown opens his mouth to defend Neves and his stance he is zig zagging.

Brown is lacking originality and has no telecommunication depth to speak intelligently in a business context about TCI

neither does Neves who has no proven business genes. It's all about the money in their eyes to the point their cognitive distortions are becoming a detriment to the public who own TCI.

The Bible says; Without a vision the people perish. This is exactly what is happening, the failure by arrogant neglect for the CIP government to deliver visionary policies that unify the people has led to society becoming fragmented and hostile over policies trumped by Neves.

Neves treatment of New Zealand pension recipients led to the formation of the underestimated Grey Power movement that has grown in strength, the very unpopular tax changes and the rise in government fees and charges pushing up the cost of doing business has fuelled an undercurrent of anger in the business community. The growing resentment to the Te Mato Vai project is yet to see the force of their anger at a secretive government and the compromising DPM Teariki Heather who some say he boasts he'll be making \$10 million from TMV. Resistance to the TCI sell out by Neves and Brown is gathering momentum and the inevitable back lash will be severe.

People protest movements and uprisings have sprung up all around the world confronting governments who have lost touch with the masses. As disillusionment and frustrated discontent heighten and the different groups unite, unprecedented public protests will force the government to call new elections. - George Pitt

## MFEM silent on impact of removal of egg levy

**D**ear Editor  
I have been a bit pre-occupied and could not respond earlier to Mr James Webb's response to mine in CI News of 3 February predicting doomsday for local egg production and asking more questions.

Fairly predictably Mr Webb's replies (08.02.14) have been less than forthcoming.

Basically what he is saying is: It is not our business to tell you how to run your business while we put you out of business, and Come and talk to us privately so that we do not have to address your many pointed questions in the public domain.

Well that is not good enough except in the case of egg levies it seems.

On the doomsday date of 1 April for the removal of egg levies he says 'Public confirmation was given by Government in December' so despite the fact I am hearing whisperings to the contrary I now take it that Mr Webb, being the inside chap that he is, is reconfirming this is Government's intention and all business decisions should depend on that. Right? So at least that is one question sort of answered albeit in a somewhat circumlocutory fashion and whether reliably or not we will just have to take further losses and wait and see.

As to my many other questions still no reply. Mr Webb occupies the privileged position of determining public policy but hides behind lame excuses when challenged on them. 'Come and

talk to us in private!' What a crock! If you are so confident in your analysis answer the questions so interested members of the public may share in your revelations. It is not as if we believe you when you say you would get no work done if you engaged every public enquiry because frankly I doubt that there are many, besides, few would be as persistent as I in pursuing you so there would likely be precious few in the queue.

Also, don't talk to me about lowering consumer prices. I have already told you that the removal of levies on pork and eggs for the outer islands made not a jot of difference yet you persist in this self-deception.

You want to know how to lower prices to consumers then adopt my earlier advice and return to a price control regime for essential groceries and if you are really serious about underpinning this protection then enact the Commerce Bill which the Government has promised to deliver but hasn't.

Both the return to Price Control on basics lines and a Commerce Act would provide the foundation for real protection yet rather than do these things Government (through its economic mouthpiece) blathers on about the remarkable panacea levy removal will achieve. Failure to take the hard decisions is testimony to, and strengthens the notion that, Government is not really sincere but continues to demonstrate its blind obeisance to its friends with vested interests who would have no desire to see

either a return to rigorous price control nor a Commerce Act. The last Price Order (for grocery lines) was 8 years ago. The Commerce Bill has been delayed now for 11 years. Whose influence is behind this do you think? While Mr Webb may be under the impression that he is pulling the strings, determining economic policy and is the architect of the grand design I suggest that he and his colleagues are merely pawns in a grander scheme and are being engineered, manipulated and out-manoeuvred by people alot smarter than they.

Because of all the foot dragging, misguided reasoning, misconceptions and inability to be more innovative and think beyond the text book and the global model I believe a case can

be made out to enlist the services of the BTIB and the invocation of the provisions of S.35A-D of the Development Investment Act to conduct an investigation into the role of MFEM and how its policies, decisions and operations conflict so seriously with, and undermine, the statutory requirements of the BTIB functions pursuant to S 16 of that Act to promote an environment conducive to development, investment and trade because it would appear to me that MFEM, with its tax policies, intransigence on glaring issues, blindness to the need for price control, commerce regulation, some original thinking and innovation would have to be the biggest contributor to the economic ills that afflict us today.

## Digicel interest in Telecom

**D**igicel is currently in advanced discussions with TCNZ and The Government of Cook Islands to purchase a majority shareholding in Telecom Cook Islands. There are some of us Cook Islanders who believe that the mighty Digicel is not the most appropriate organisation to be handed control of the monopoly in an industry sector of such strategic national importance.

In frank dialogue with the Minister for telecommunications last Friday 14 February, Mervin Communications (MCL)/KukiCel Company Director William Framhein outlined his concerns in two key areas. Firstly that the Minister is choosing to waive The Government's first right of refusal in acquiring Telecom New Zealand's (TCNZ Cook Islands) shares in Telecom Cook Islands (TCI) subject to those shares becoming available for purchase. Secondly, the apparent lack of evidence or report showing that Government has carried out due diligence on Digicel.

During the meeting the Minister was asked to change his position on waiving Governments first right of refusal in acquiring the TCNZ shares in TCI as Framhein pointed to the local interest in taking a position in TCI should TCNZ receive an offer from Digicel.

## **PUBLIC NOTICE FOR PENSIONERS**

In getting ready for the 2.5% VAT increase on 1 April 2014, from 1 March 2014 the local Cook Islands pension will increase by 25% for both the over 60 and over 70 categories.

To ensure fairness, and to direct the increased payment towards those most in need, from 1 March 2014 the local Cook Islands pension will also become part of your taxable income.

To help ensure that individuals receive the correct payments and are not left with tax debts at the end of the year, pensioners will **need to register their Revenue Management Division (RMD) number with the Ministry of Internal Affairs by 20 February 2014.**

If you do not have an RMD number, the Ministry of Internal Affairs can organise one for you – it's free and easy to do.

All other social welfare payments will also increase by 10% from 1 March 2014 but will not require you to register your RMD number.

When combined with the personal income tax cuts, every pensioner in 2014 (regardless of income level) will have more money in their hand than they did in 2013, which will assist in adjusting to the VAT change on 1 April 2014.

A tax calculator has been made available at [www.mfem.gov.ck/tax](http://www.mfem.gov.ck/tax) for individuals to estimate how the changes may affect them.

Pensioners are encouraged to contact a Welfare Officer in the Ministry of Internal Affairs in Rarotonga, or the Internal Affairs Officer in Pa Enea **before 20 February 2014.** There is a simple one page form required.



# QR Appoints Anthony Brown as new Official Secretary

**Q**ueen's Representative His Excellency, Tom J Marsters has appointed local practicing lawyer Mr. Anthony Brown as the new Official Secretary of the Office of the Head of State as of Tuesday 18th February 2014.

In a press statement, His Excellency cited it was his pleasure to appoint Brown to the prestigious post with much support of the Prime Minister, Honourable Henry Puna and the Public Service Commissioner. Brown is a former Director of Labour, Director of National Disaster Management and Secretary of Agriculture and took up legal practice from 2012 till this appointment. Brown is able to resonate with public administration however, this time, at a constitutional level envisaged within the realms of the Office of the Head of State.

Brown takes over from a retiring Harry Ivaiti who has achieved 40 years of public service and was highly recognized by His Excellency for services rendered to the Head of State, Office of the Prime Minister and Cabinet, the Parliament and the Educational sector. The QR said he

accepted Ivaiti's resignation for retirement noting his current condition of ill health and that he and his wife prayed for Ivaiti's recovery.

Brown has a double degree in Administrative and Political Science from the University of Canberra, Certificate and Degree in Law from the University of the South Pacific and a Diploma in Management Studies from Wellington.

Brown told the Herald it was 'an Honour to Serve the Queen especially in the person of His Excellency Tom Marsters as a man of high public stature, dignity, astute and noble. Brown has already found in his own opinion "an issue of juxtaposition in the Constitutional Amendment with Article 75 in respects of Article 1". A matter he has already expressed with His Excellency.

Brown's appointment continues a proud family tradition, as his father Mr Maine Brown (as former Public Service Commissioner) was also the first Official Secretary to the Head of State in 1983, with the late Sir Gaven Donne followed by the late Sir Tangaroa Tanagroa and the late Sir Apenera Short.



# Shallow water fish aggregate device (FAD) deployed for Arorangi

**L**ocal fishers and mariners are being advised that a shallow water fish aggregate device (FAD) has been deployed by the Ministry of Marine Resources (MMR) seven hundred meters offshore from Arorangi School.

Senior fisheries officer Sonny Tatuava advises that the FAD was rigged to support coastal fishing activities that take place in the locality such as trolling of surface pelagic species, deep bottom fishing for snappers, bait fishing for the scads "ature" and "Köperu" and night fishing to catch snake mackerel Mangā.

The final site location was decided after consulting with the local fishers, Arorangi fishing club, Ports Authority and the Member of Parliament. Advice for the bathymetric survey conducted by MMR staffs was provided surveyors from MOIP.

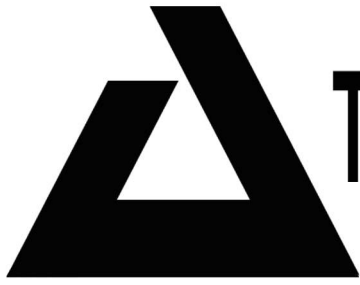
This is the eleventh FAD deployed around Rarotonga. It will provide easy access for Arorangi fishers to the fishing grounds and help save on fuel costs and improve sea safety.

The latitude and longitude of the FAD is 21°14'.160 and 159°50'.130, respectively.

They took this initiative as an extension of what BCI is about – sustainability, self reliance and looking after our people. Initially the programme will be open to home owners who have houses here on Rarotonga, and will be rolled out to the Outer Islands as professional installers of the solar kits expand their services to include them. This programme will be open to all home owners on Rarotonga, whether they are BCI clients or not, provided their house is here and they meet the eligibility criteria. This criteria is based around the value of the house and ability to service the loan, with the term being flexible to fit around power savings wherever possible. # China warships in Pacific raise alarm

*Beijing flexes its maritime muscles with unannounced war exercise in international waters*



Three Chinese warships have sent dark new clouds scudding over Australia's strategic horizon, adding to growing unease across the region as Beijing flexes its muscles through the Indian Ocean to the western Pacific.

The sudden appearance near Australia of the guided missile destroyers Wuhan and Haikou, in company with the advanced, 20,000-tonne landing ship Changbaishan, led to the RAAF Orion patrol aircraft being scrambled and sent north of the continent.

Although operating legally in international waters, the unannounced passage of the ships through the Sunda Strait between Java and Sumatra to the Lombok Strait off Bali has been seen as a clear message that China is now a major maritime power operating wherever it wants to go.

The series of 10 exercises between Indonesia and Australia was also a demonstration of China's increasing might, reach and sophistication as the emerging superpower ramps up its territorial claims.

The implications have triggered concern also in India, Japan, Southeast Asia and the Philippines, and raised further questions about Beijing's increasing presence in the South Pacific - particularly its development and expansion of

ports in Tonga and Papua New Guinea.

The United States has already responded with a shift in its naval emphasis to the region, increasing its marine presence in Australia and the intention to base 60 per cent of its warships in the Asia-Pacific region by 2020.

By that time China's navy will have become even more formidable. Funded by an economy that is now the world's second-largest and on track to become the biggest, Beijing's US\$110 billion (\$132 billion) defence budget is exceeded only by the US.

Its sole aircraft carrier, the Liaoning, bought from Ukraine and refurbished, will be joined by an 80,000-tonne nuclear-powered vessel within six years, with plans for four more. As well as a larger, advanced surface fleet, China's ballistic and attack submarine force will also be significantly expanded.

Chinese warships are rapidly gaining new potency through advanced technology. This month a Song class diesel-electric attack submarine slipped past screening US warships to surface within striking range of the aircraft carrier USS Kittyhawk. That set the alarm bells ringing.

In the Lombok Strait, the three Chinese warships conducted exercises including fast-response electronic warfare, anti-missile defence, and attack co-

ordination.

State television said no advance warning of the mission had been given as "part of the navy's plan to simulate actual combat conditions".

Analysts have seen a number of signals in the deployment beyond the demonstration of power, reach and "self-confidence" advocated by policymakers in Beijing.

Among these is the ability to protect the sea lanes vital for its energy imports, and the potential to use alternatives to the Malacca Strait if the key route was closed.

The exercise was also the first to extend beyond the western waters of the Indian Ocean, and to come so close to Australia.

Last October, similar capabilities were demonstrated when Chinese warships, supported by bombers and patrol aircraft, passed through the Japanese archipelago to conduct war games in the western Pacific, alarming Japan.

With tensions already high over the disputed Senkakus/Diaoyu islands, Tokyo increased its defence budget, announcing plans for more strike jets, warships and other hardware.

India is also concerned at China's operations in the eastern Indian Ocean, worrying that Beijing is placing the crucial waters around the Andaman and Nicobar islands within reach of

its military.

China insists that its naval operations present no threat to other countries in the region and that its Lombok Strait exercises were part of annual training plans during which its navy upheld its right to free passage in international waters.

China has also been increasing cooperation within the region, joining US warships for search-and-rescue exercises near Hawaii last year, and sending ships on goodwill visits to Australia and New Zealand. This year it will take part in the huge American Rimpac naval exercise off Hawaii.

Prime Minister John Key has said New Zealand "doesn't feel concerned by anything [China] might be doing", a view also expressed after the Lombok exercises by Australian Foreign Minister Julie Bishop.

Noting that the exercises took place in international waters, Bishop said: "The Chinese navy is growing, commensurate with the increase in size and strength of the Chinese economy and its place in the region and its place in the globe."

Lowy Institute international security programme director Rory Medcalf wrote that there was nothing illegal or fundamentally hostile in the exercises, and that a greater Chinese role in the Indian Ocean was inevitable.

##### Make Your Own Power Plan

Windows laptops include a few preset power plans for maximizing battery life, but you can also customize your operating system's power-management features (in Windows XP, under Power Options in the Control Panel; in Vista, under Mobile PC in the Control Panel). Setting aggressive targets for when the display turns off and when the machine goes into sleep or hibernate mode will help your battery last longer.

##### Limit Your Connection

When you aren't actively using your notebook's Wi-Fi, Bluetooth, WWAN, or other wireless connections, turn the radios off (via the hard switch, if your PC has one, or using the appropriate utility), so they don't run down the battery while they keep searching for a signal. Also, use USB-attached devices sparingly while you're mobile.

##### Track it down

Thousands of laptops are reported stolen every year. Our advice? Prepare for the worst by investing in tracking software like Absolute Software's Lojack for Laptops, CyberAngel Security, or the free TheLaptopLock. These utilities can pinpoint a registered notebook's location once it connects to the Web, increasing your chances of recovering your system.

##### Dim the display

A laptop's biggest battery-life-sucking component is its LCD display. To eke out more juice when you're off the plug, turn down your panel's brightness to the lowest level your eyes can stand. Most notebooks have a Function key combo—or even a dedicated hot key—for a quick crank-down. (You can also adjust brightness in Display Settings under Control Panel.)

# Memories of my fallen MP friends

In my 31 years in Parliament, 29 of my peers have passed on. I wish to share some of my experiences, involving them, with you, in alphabetical order.

I continue with Papa Tom, Sir Thomas Davis. It is often said that power corrupts. When Papa Tom met up with Pa Terito Ariki of Takitumu, he became Pa Tuterangi Ariki when they got married or Pa Tane.

Papa Tom always carried airs of eminence as he was a brilliant scientist who worked for the NASA Space programme. Add to this a knighthood and an Ariki title, on top of being Prime Minister of the Cook Islands you have the most powerful man in the nation with unlimited powers. That signalled alarm bells.

Papa Tom took on airs greater than those of a simple Prime Minister. He decided to attend the Commonwealth games in Scotland in 1986. He decided that he had to have an aide-de-camp, with Lady Davis having a lady-in-waiting. In cabinet I advised him that the privilege was for a Head of State only, not to mention the prohibitive costs of taking two extra people. When he ran out of excuses, he simply said to us in Cabinet, "let's call it a leaders privilege". He carried the day.

Before he left, Papa Tom tried to persuade Sir Tangaroa Tangaroa to sign an undated "revocation or dismissal Ministerial Warrant". He wanted to carry a signed dismissal warrant without a name or date. If a Minister upset him all he had to do was write the Ministers name down and the date! I knew that was designed from me!

To his credit Papa Tangaroa refused!

In 1985, there was major fallout between New Zealand Prime Minister David Lange and Papa Tom over the Defence Treaty called ANZUS between

Australia, New Zealand and the United States. That was the time New Zealand declared itself a nuclear free zone, which prohibited U.S. warships from visiting New Zealand if they carried nuclear weapons.

Papa Tom charged in with pro USA postures. There were jokes about a new treaty to be called "CANZUS" to include the Cook Islands. Papa Tom welcomed US warships to visit Rarotonga instead, but the US Government wisely declined. They did not want to fracture the relationship further.

Three other events shook our relationship with New Zealand at the time! When Papa Tom taunted NZ P.M. Lange about New Zealand inability to defend the Cook Islands, New Zealand ordered the biggest military exercise held outside of New Zealand in the Cook Islands in Rarotonga and Aitutaki.

The cost was rumoured to be NZ\$31 million.

After so much ground work to shift aircraft and equipment to Rarotonga, with me as Foreign Affairs Minister working closely with the NZ Government, Papa Tom tried to pull the plug on the exercise.

A week before the military exercise, Papa Tom called for a special cabinet meeting. He announced that the Ui Ariki and Aronga Mana wanted him to cancel the exercise. I advised him that Cabinet unanimously approved the exercise, he must understand the ramifications of collective decision making, if one cabinet Minister disagrees with the rest, then he must resign. I also advised him that the Ui Ariki and Aronga Mana had no role in Cabinet decision making.

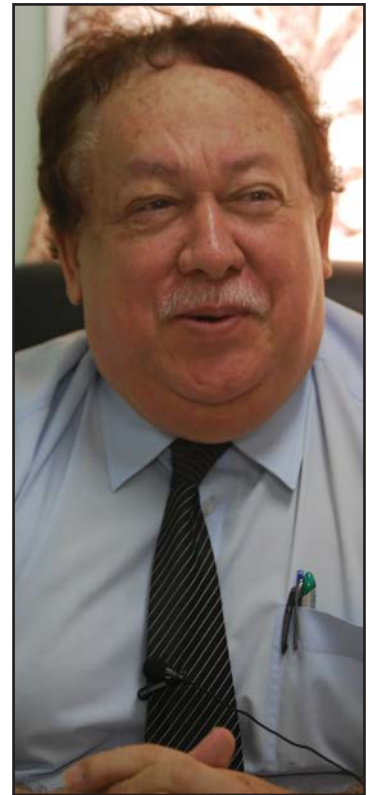
He switched to saying that as Minister of Defence he had a right to cancel the exercise on his own. I asked him to point to the constitution to tell US where it says that. He quickly backed down and a successful exercise was conducted.

During the South Pacific Forum of 1985 held in Rarotonga, Papa Tom again tried to buck the system by initially refusing to support the South Pacific Nuclear Free Treaty. We in Cabinet persuaded him that as the hosts this is a once in a life time opportunity to take the lead. Reluctantly he supported it. When we made an official visit to New Zealand in 1986, I was in shock when we went up the Beehive to meet PM David Lange. He welcomed us to our seats, and then started reading out a prepared press statement. He said something like .... "at a meeting between the two Prime Ministers, it is agreed that the Cook Islands is now free to declare full independence!... He was still trying to read on when I interrupted.

Lange, I said, "Prime Minister it is not as simple as that.... our status is entrenched in our constitution. A referendum must first be held and supported by 75% of the population.

I also advised him that the people of the Cook Islands will throw us out of Parliament, if they hear it. The speech was screwed up and ended up in the rubbish bin. All these incidents were never released to the public.

The last of Papa Tom's demise was when he removed



\$350,000, from the Mangaia Island Pineapple budget in 1987. Matepi Matepi led the charge to remove him. I was in Samoa at the time, but was recalled to Rarotonga. There was clearly majority of caucus against Papa Tom.

His replacement was decided between me and Papa Pupuke Robati. I will reserve the drama of selection to another time for the record; I conceded the position to Pupuke Robati.

# Thank you for not forgetting us

I have got some good news for you."

The good news is that the old people in the Cook Islands, who receive the Cook Islands Old Age Pension, are all getting a significant benefit increase as of 1 March 2014. But everybody already knows that by now.

However ... to recap : for those aged between 60 and 69, their benefit goes up from \$400 a month to \$500 a month (\$6,000 for the year). And for those 70 years and over, their benefit goes up from \$500 a month to \$625 a month or \$7,500 a year.

For a married couple of 70 years or more for example, this gives them a combined monthly income of \$1,250 ... or about \$315 per week.

And all this pension money is "tax-free" because this income is under the "tax-free" threshold of \$11,000 per person, per year.

... now for the "real good news."

This being that the Old Age Pensioners are grateful, and thankful to this Cook Islands Party Government for giving all of them such a significant increase in their benefit payments.

While some, because of their political persuasion to the "other mob" will be quite happy to "take and say nothing in acknowledgement", the vast majority of pensioners throughout the country will accept these benefit increases with open gratitude and heartfelt appreciation.

These people are the "Real Grey Power" in the Cook Islands. Not that small "fringe group" of individuals who are always on TV, and sponsored by the Democratic Party, who keep trying to "Run the Government down" every TV chance they get.

It is common knowledge that the Old Age Pension was Albert Henry's "Pet Policy" when he formed the Cook Islands Party in 1964. It is also common knowledge that he and his Government introduced the "Cook Islands Universal Old Age Pension Scheme" in 1966.

They will remember how it was a real struggle just to earn a living to put food on the table to feed their families.

The vast majority of people of that time were living in homes that still had thatched roofs, no electricity, no running water inside their houses. Hard work was an everyday necessity with very little money in hand.

#### The 1st Cook Islands Party Government/Cabinet of 1965

These were the men who introduced the Cook Islands Old Age Pension Scheme in 1966.

The Government of 1965 inherited an economy based entirely on the export of copra and "Raro Juice". They were basically broke from Day One.

But collectively, the Government, and the people of

that time toiled and worked and strove to create a better a better way of life, a better standard of living and a better and more prosperous future for all to share and enjoy in later years.

It is those "workers" from the 1960's 70's and 80's who are now retired and so collecting the Old Age Pension.

They earned this money through sweat and toil during a bygone era.

They earned the "benefit" they are receiving today through hard work, sacrifice and great personal effort to bring up their children and to provide for their families at a time so vastly different to what we have in the Cook Islands today.

Before any smart-alec jumps up and down to claim that we only have an Old Age Pension Scheme because it was funded by New Zealand Aid money, let me knock that assumption on the head right at the start. Aid money from New Zealand, or anywhere else, has never been used to fund this scheme. It has always been funded by the Cook Islands Government from its own financial resources.

Sometimes it is very hard for a Cook Islander to say "thank you" ... for anything.

More often than not it is a "take-take-take" and no appreciation offered or gratitude given.

But in this case, I am sure, all

the Old Age Pensioners in the Cook Islands, who are going to get a benefit increase, are thankful and grateful to this Cook Islands Party Government. However, because of their political opposition to the C.I.P. there are some who would never openly admit it. But that's OK. I've got no problem with that.

The vast majority of the "Real Cook Islands Grey Power" are not like that. They are thankful and grateful for the money being given to them on a fortnightly basis.

I think it is only appropriate that a "thank you" be given to all the wage and salary earners who are paying P.A.Y.E. as well as all those businesses who are paying VAT to the Government. "Thank You" also to all those companies paying "Company Tax" and to those individuals and businesses who pay import levies and other fees and costs to Government for what ever reason.

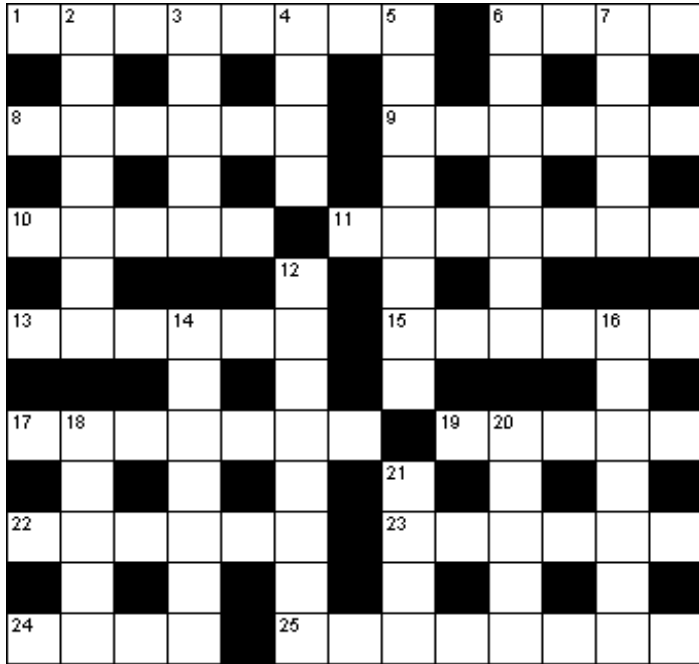

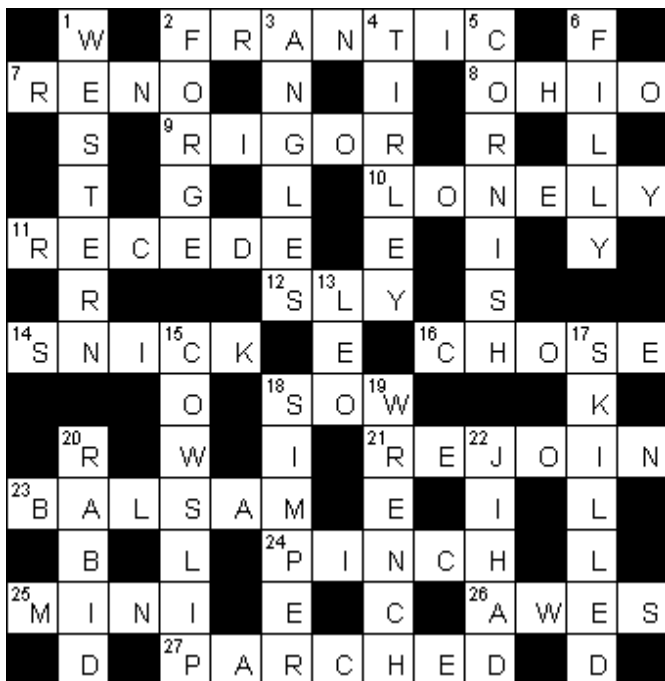

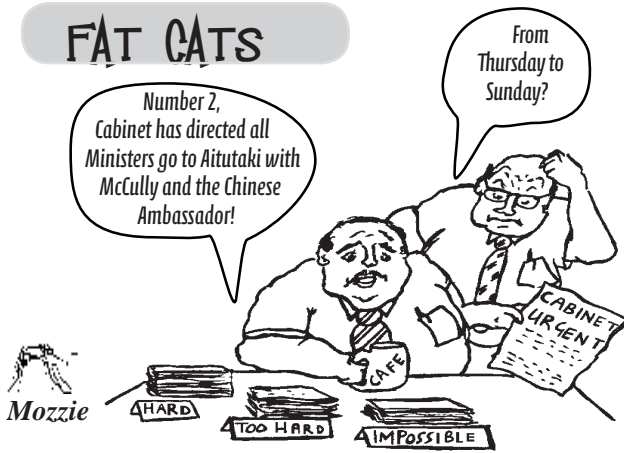
