

Brown kicks off campaign with the green bottles



Takuvaie CIP Candidate Mark Brown

The CIP heavy weight candidate for Takuvaie Mark Brown is either ignorant or arrogant when it comes to the contents of the Electoral Act. Last Friday 25 April after the visiting Aitutaki Shark's thrashed the Takuvaie Warriors rugby league team in a clash at the Takuvaie field Brown cashed in on the after match refreshments with a contribution of several cartons of beer.

Several witnesses and players were surprised at Brown's unusual generosity as this was a first for the season which is drawing to a close. Not surprised were other observers who considered Brown's gesture a vote buying exercise. If Brown was genuine in contributing to the Aitutakians as guests of Takuvaie he should have donated the beer

anonymously instead of him doing so openly.

Before polling day a good two months away Brown's gift of alcohol is subject for an electoral petition should he win the Takuvaie seat on the 9 July. Under section 89 of the Electoral Act 2004 Brown can be petitioned for treating.

If the Demos registered a candidate then did absolutely no campaigning they have more certainty of toppling Brown in Court for treating than at the polls. This would be the most cost effective victory of all time in the history of Cook Islands politics.

In the recent Murienua by election petition lodged by the losing Cook Islands Party candidate Kaota Tuariki against James Beer, the presiding Judge Sir Hugh Williams sent a clear message where he is

positioned regarding treating and bribery.

Having no regard for the rules of the Cook Islands Party constitution, Brown takes no caution to the wind regarding Sir Williams' implications in his summing up of the Murienua petition. If Sir Williams was signalling a message of interpretation and caution to future candidates, Brown certainly missed it by a country mile or he considers himself bullet proof.

One candidate, George Maggie certainly read between the lines and got the message and has advised his supporters of the high risk of even providing a light supper after or in conjunction with a political meeting. When Maggie explained the judiciary's eroding tolerance of the Electoral Act in the

context of Cook Islands culture and traditions those in attendance applauded his explanation.

In an effort to rid politics of the years of border line petition decisions regarding allegations of treating and bribery (in the name of culture), some members of the public and party officials are now a lot more vigilant in their scrutiny of campaigning candidate's attempts to lure voters to their fold.

Though the consequences of being found guilty of bribery in an Electoral Petition are very serious and can result in a criminal conviction and imprisonment, no one has been prosecuted or is considered by candidates as a deterrent judging by current electioneering practises.

Incidentally a well known Takuvaie local took exception to Brown's presence at the Club House that he verbally sprayed him with abusive accusations of all talk and no action causing Brown to make a swift exit into the night.

To cap off a week of disrespect for rules, Brown and his CIP Committee held their political meeting in the Takuvaie meeting house, a no go zone for such meetings. The total disregard for this long standing Pa Metua rule has sent a ripple of concern through the constituency; then again Brown has already established a track record of examples of his low tolerance for the elderly and their values. Political meetings are tolerated on the veranda of the meeting house but not inside it. As it happened, only 10 people showed up and some left before the meeting ended.

Diversion of sports funds by Minister hurting sports codes

Minister for Sport Mark Brown's actions in approving the allocation of \$78,000 from the Allsports Fund intended for CISNOC for distribution to the sports codes, has left sports codes wondering just when they will receive funding for sports programmes such as development programmes.

In the 2013/2014 Budget, government appropriated \$120,000 for CISNOC's Allsports fund. Of this amount, \$30,000 is for CISNOC Administration and \$90,000 to be distributed to CISNOC members. Shortly after he had approved the funding, the Minister advised CISNOC he had approved allocating to CI Rugby League (\$60,000 and CI Netball \$18,000 – total of \$78,000.

Recently, the Herald was advised that some sports are unable to fund development programmes because their funding has not come through. Boxing is awaiting \$5,000.

The Herald has received word that some sports codes are very upset that the funds were diverted to just two sports codes alleging favoritism on the part of the Minister.

On 23 April 2014 the Herald asked CISNOC President Hugh Graham to comment on the situation. His responses are set out below. There is concern that as parliament has been dissolved there will be delays in the codes receiving their funding.

Hugh Graham: "When CISNOC heard that parliament had been dissolved, I texted the Minister and asked him to clarify for us how the \$78,000 would be repaid into the All sports allocation now that since the Supplementary budget was not going to be presented. The Minister assured me that under the CI Constitution and under a caretaker govt, he will be able to release funds... he has assured me that the \$78,000 will be repaid to the Allsports funds in the next week or two. To this effect, the Allsports

Funding committee, under the Chair of Senior Vice President George Paniani met last Wed 16 April and have considered and approved those outstanding applications on the condition that funds would be released to those successful applicants once the \$78,000 had been paid into CISNOC Account."

The Herald understands national sports federations have been waiting over 6 months for funding. The allocation of funds by CISNOC to the sports codes is done according to clearly established criteria based on applications made by national federations and the process is transparent.

After queries by national sports federations in recent months as to why there have been no allocations of funds, it was disclosed at CISNOC's recent AGM Government instead of passing the allocation to CISNOC to distribute to national federations, paid \$78,000 directly to rugby league and netball after these sports approached the Minister directly.

Hugh Graham: "The 2013/2014 Allsports Funds appropriation was \$120,000. Of this amount, \$30,000 is for CISNOC Administration and \$90,000 to be distributed to CISNOC members. I was advised by the Minister shortly after he had approved the funding to both CI Rugby League (\$60,000 and CI Netball \$18,000 – total of \$78,000) and that we would expect the repayment into the Allsports Funding appropriation during the 2014 March/April Supplementary Budget.

I have been advocating for these funds to be put back into the Allsports Funds Allocation so that we can give to sports. The Minister has been open with me in my communications with him, and whilst some of our member sporting codes may not agree with me, the Minister has yet to go against his word in terms of CISNOC issues since I was elected President of CISNOC almost 2 years ago.

I appreciate and understand the frustrations of our members, I ask for your patience.

With the recommendations that we will be suggesting to the Minister and Internal Affairs, who manage these funds, we are hoping that once government appropriates the Allsports Funding that these funds are paid in total into the CISNOC account, this way there will be no chance for government to otherwise interfere with this process. The Minister is receptive to these recommendations."

One comment received by the Herald was that It was a clear case of the Minister of Sport "picking favourites" and it is noted that the Minister travelled to the UK to watch the Rugby League World Cup. A fair question is how was his trip funded?

Another comment made inferred the Minister had misappropriated funds intended for all sports not just two sports. Some 26 national sports federations are part of CISNOC and this funding shortfall severely hampers their development programmes and other prospects. Also the Minister approved the allocation to two sports without any apparent discussion with CISNOC. Any approval should have included an approval from CISNOC itself.

Note: The Minister was contacted by email on 23 April 2014 regarding this matter but at time of going to print, is yet to respond with a comment to the issues raised, let alone acknowledge receipt of the concerns expressed.

No eateries specializing in healthy meals

There are no eating places on Rarotonga that are 100% devoted to providing healthy and nutritious meals. With NCDs, diabetes and obesity a major problem how can customers who want a healthy meal because they are on a diet or health conscious, be assured the meals they order at eating places are low in calories, low in sugar content, low in fat content and low in salt content?

Last Thursday morning the Herald spoke to the owner of a local restaurant on how owners can prove/show customers that their food is healthy and nutritious.

His comments were;

"It's the owner's job to make sure that the food on their menu tastes good, looks presentable (the presentation of the meal) and the combination of the meal. The owner doesn't really look at the calorie count of the food. It's more the costumer's job to ask what is in the food before they order. What is common is that a lot of people have allergies to food, so to make sure that the dish they want does not have anything in that they can't eat they should inquire about the dish. I don't think any restaurant in

the Cook Islands has symbols on their menu to inform the customers if it is healthy or unhealthy. The owner of a restaurant labels their food from their menus."

"The Cook Islands has laws/regulations in the Cook Islands that we don't know, how do we know this? In the Food Regulations of 2014 it states that you cannot sell nutritious food unless you can prove that it is nutritious."

Public Health can assist eateries

Local businesses such as eateries and market vendors, who are aiming at providing healthier food choices, are encouraged by Public Health Division's Health Promotion Officer, Karen Tairea, to provide customers with a wide variety of options for their daily meals.

Although businesses sell to their desired target range, she advises that it is always good to have other options

available for them from time to time. With locals now changing their eating and dietary habits to fit in a much more healthier and nutritious life style, locals are encouraged to take advantage of the services provided by the Public Health Division that can aid business owners in providing healthier choices for the public.

The public health sector can offer generic information to owners who are looking to provide healthier products, and can also advise them on the dos and don'ts of Health and Nutrition. Looking for substitutes and alternatives to salt, sugar and high fat content can make a huge difference in ones day-to-day eating habits or can be as simple as giving customers options on whether or not they would like to add as much seasoning to their meals or not.

Well, how would the public know if the food their eating is healthy or not, you might ask? That all depends on how much information the merchant is willing to disclose to the individual. This is because most companies do not wish to share their secrets as to what make their food desirable.

For more information on what you can do to make your retail outlet a healthier,

nutritious stop for your customers, stop into the Public Health Department and get some expert help and advice from the professionals. Again Karen says, "It depends on what they (vendors) feel the needs are", so there is not set criteria as to what a vendor or business can follow.

Public Health have also been working, in collaboration with the Business, Trade and Investment Board (BTIB), to help market vendors improve the ranges of food products that are currently on sale. Another initiative that the Public Health sector will be looking into is starting up a catering module with the Cook Islands Tertiary Institute, (CITI) where local food businesses can send staff in, along with students, to train and be educated along the lines of creating and adapting to healthier food choices.

The Public Health department can neither insist nor demand that businesses be more in tuned with a healthier and nutritious standard. The best they can do is to encourage the vendors and businesses to provide their consumers with other alternative options to items whose ingredients taste incredibly good, but aren't all that healthy for the individual.

Promoting Healthy Living

Nadia George talks to Sue Carruthers

With healthier eating choices becoming a hot topic among local businesses, the Herald recently spoke to local culinary entrepreneur, Sue Carruthers, better known for operating the Tamarind with her partner Robbie, who takes pride in promoting healthier choices at her establishments.

Sue says that it's good to always give customers a variety of options, which is what she, aims to promote in the recently opened, Mexican styled restaurant, La Casita. From vegetarian to gluten free. In all

three restaurants she owns, all have healthy options to serve up to their customers such as whole meal, brown rice, salads etc. Fresh produce is one of the many things that Sue likes to promote as a definite "do" in healthy food choices. The key is to trying not to use too much of processed foods available to everyone, cutting down the oil and fatty deep fried foods is what's best in making a shift to a healthy lifestyle. Using a lot of fresh produce is not only a simplistic healthier option, but is also her way of supporting local growers on the island.

Although healthy foods don't appeal much to locals, Sue believes that the best way to

promote a healthier lifestyle in the Cook Islands is to first start in the home. Urgent action needs to be taken now. Parents should start educating school children on what foods are best to eat. Starting from a younger age is always best as it develops habits within children, thus enabling them to make much healthier choices as they age on. It could be as simple as changing up a child's lunch from a packet of uncooked noodles, to say, a whole meal peanut butter sandwich, or even just balancing out a meal with a bit of salad or a banana.

Finding substitutes is also another option people should take into account when eating

or preparing a meal; substituting things such as salt and sugar to help limit chances of developing Non Communicable Diseases (NCD), which account for about 70% of all deaths in the Pacific region, yet many are preventable. The 10 countries in the world with the highest overweight and obesity rates are in the Pacific so eating lots of fresh fruits and veges, which are available to most families on the island, is always a good thing to add into your daily diet.

Sue encourages locals to try and eat as much natural food as possible. Healthier choices make for a healthier lifestyle and better living.

Tourism to aim for visitors who spend more

On the 28th of April, the Tourism Industry Members Seminar was held at the Muri Beach Club Hotel. Professor Simon Milne of Auckland University of Technology has visited our shores to shed some light on the Cook Islands Online International Survey.

The survey was conducted in order to obtain relevant and useful information on the tourists who choose the Cook Islands as their holiday destination. "The survey is ongoing and it is mainly a decision-support system," says Milne. This will enable the nation to plan and further develop strategies in which they could attract a certain market. This survey in particular was conducted online. Visitors provide the airport with their email addresses and with that, the surveyors contact them. Around 30 – 40% responded to the request and approximately 8000 surveys were conducted. "This is a robust number to work with."

They questions posed in the survey were aimed to attain more information about the average visitor's experience within the country and their expenditure on the duration of their holiday and before

arriving (travel packages booked online: hotel accommodation, transport, activities etc.). Milne was able to give an estimate on how these visitors responded to the survey:

- Over 90% of visitors who were surveyed said that they would return to the Cook Islands

- Nearly 100% of them would recommend the Cook Islands as a holiday destination to other people

- Majority of the responses were positive, with regards to the local experiences and shopping trips.

Information was also obtained on how much money they spent on general necessities, such as petrol, grocery shopping, souvenirs etc. According to Milne, this data will allow the Cook Islands Tourism Industry to focus on attracting a high yield market – a market which will spend more during their stay. "We don't have to necessarily increase the number of tourists coming in the country, as there will be challenges" he says. "We just need to focus on a certain kind of visitor which is relatively sustainable and get more economical benefits out of everyone who arrives."

The average visitor spends approx. \$2000 - \$2200 on travel packages before arriving in

the country. During their stay, the average visitor can spend approx. \$120 per day on each person, both child and adult, amounting to well over \$1000 per week.

However, there are still some issues which Milne considers that we should address, such as the maintaining of our environment and managing the dogs on roads. "People come here for the tropical paradise

and are sorely disappointed when they see the state of our beaches." However, Milne says that this is the minority, not the majority.

Milne would like to place emphasis on the benefits that tourism brings to the Cook Islands and believes that if tourism works for the community, the community would be willing work for tourism.

The Prime Minister Henry Puna will be welcoming Pacific Islands Forum leaders back to Rarotonga this weekend, ahead of a Special Retreat to consider the outcomes of the 2013 Pacific Plan Review.

The Review team was led by Sir Mekere Morauta, a former Prime Minister of Papua New Guinea, and its report was presented to Leaders last October.

The Prime Minister said Leaders had agreed in Majuro in September 2013 that a special meeting was required to focus their attention on the broad range and number of recommendations that resulted from the region-wide review. Government offered to host the Retreat about three months ago and the Forum Leaders accepted the Cook Islands to be the venue for their discussions.

The Review reached as widely and deeply as it could into the member countries' views on the Pacific Plan and what it meant to the region. Leaders are now considering how the framework can be better improved to deepen regionalism and encourage greater levels of integration for the benefit of member countries that must contend with wide-ranging challenges and constraints.

During his tenure as the Forum Chair in 2012/2013, the Prime Minister had called for review outcomes that would better suit the changing times and provide a more relevant and effective Plan to assist the member countries. His approach was built on promoting "a new sense of optimism" with a more "dynamic" Plan.

"Our sense of regionalism must grow stronger and more acute with each passage of growth, and as each new demand for a shift in priorities takes hold. Over time, emerging issues do eventually become more entrenched and the efforts required for embracing solutions in a collective and effective way, demand ongoing adjustment, or adaptation. Regionalism itself is evolving and how we inject it with fresh priority is where the Pacific Plan stands or falls."

Leaders are presently confirming their attendance at the one-day Retreat, which will take place on Monday 5 May. The hosting responsibility for the Retreat has a working budget of \$35,000.

Fear filled Demos ignore constitution and conference

A proud tradition of the Democratic Party has been trampled on and discarded by a fear virus spread by self interested Party officials. One of the traits of the Demos that separated them from the CIP was their openness to robust debate that new comers would often interpret as argumentative and decisive has been dumped for fear of division.

For the Demos the airing of opinions and differences of views was the way forward for it brought clarity to the issues before them. Meetings have ascended into hash words and shouting but that cathartic approach in many ways has been the salvation of the Party. So why the sudden change ask many Demo die hards?

The Democratic Party has fallen into the CIP line of avoiding a Party Conference at

all costs, many suspect to insure the current Executives and Party Leadership of Rasmussen and Heather are not challenged. The DP constitution has been compromised drawing criticism over the motives and integrity of the leadership.

At a Central Committee meeting recently much attention by emotionally charged speakers cited division as a reason not to have a Conference, such a nonsensical approach on the eve of an Election. The unelected Leader Rasmussen had the chance to cement his position by conference endorsement but avoided that for fear of being Normanised. It was almost a rehearsed staged show led by Titikaveka MP Selena Napa who emotionally pleaded with the delegates not to have a conference followed by a similar disjointed just as emotional plea

from George Hosking.

Prior to the meeting Rasmussen was on CITV local news stating there would be no conference before the Elections and as there was no apparent challenges to his leadership he would be leading the Party into the Elections.

Those aspiring to official positions in the Party were disappointed their democratic and constitutional rights were over ruled by those currently holding positions. They claim that's why they have rules and a constitution, it's to overrule the very events of the meeting, emotional out bursts that divert attention and promote contradictory actions. The rules are the protection of the organisation, they keep the focus and due processes in tack from political tampering, otherwise why bother to have them.

If they can't obey or follow

their own rules, how can the voters trust them to follow the principles of good governance? The similarities to the CIP are a disappointment to voters looking for signs of distinct differences.

The Democratic Party have set a precedent that will live to haunt them for many years. It opens a door for manipulation and sets the platform for a dictatorial leader and loyal executives to rule by whim and fancy without transparency or accountability.

Had there been elections it was a certainty all executive positions including the Leadership positions would have been robustly contested, the very fear of those postponing the conference. Political opinion . . .

“Expect the Unexpected to Continue”

What an extraordinary week it has been on the political front.

Political “bomb-shell” after “bomb-shell” has fallen to the extent I’m almost breathless trying to keep up with all the news.

Given all that has happened in the last 7 days, I am sure there are more “bomb-shells” to come before we finally get an election result on the evening of 9 July 2014.

Leading up to that General Election is going to be one of the most interesting election campaigns the Cook Islands has ever had.

I might even call it . . . “quite exciting”?

The reason for this is because between now and 10 July, “ANYTHING” could happen.

And I mean “ANYTHING” is possible within the current political climate.

Politics can be so unpredictable at times. I think there is going to be a few political “twists and turns” over the next couple of months that will be of a “bomb-shell” variety.

So be aware and expect the political unexpected. Such developments could happen at any time.

We had the first taste of this last week with Parliament being dissolved and an early election called. This move was completely “out of the blue” and totally unexpected.

The reasons Government gave for this initiative were vague and hopelessly inadequate. To dissolve Parliament with so many important pieces of legislation left hanging in the balance clearly suggests “panic stations” had set in within the Government.

Then there was the resignation of Teina Bishop from cabinet later that same day. This development came as a “bomb-shell” straight out of left field.

The next “little surprise” came with the news of a new Independent Party being formed to contest the election.

Many of us would have seen their ads on TV over the last few days. At the time of writing this article, no names had been linked to this party. So it is difficult to work out if they are likely to get much political traction or not. But this will happen shortly along with various reasons why voters should support their candidates at election time.

Just because a candidate stands as an Independent, will that mean this person has to be a financial member, and a supporter, of the Independent Party?

Answer : No . . . but only if they want to.

So it is more than likely we will end up in some constituencies with Independent candidates standing as being Independent and completely separate from the Independent Political Party.

I see a recipe for voter confusion rising out of all of this.

Never mind.

“Let the coconuts fall” on this one and wait to see what happens.

I went to the shop yesterday to purchase my copy of the 2nd most popular newspaper in the Cook Islands behind the Herald.

To my great surprise I read on the front page that Teina Bishop and George Maggie had been kicked-out of the Cook Islands Party. “Gee-wizz” . . . Cook Islands politics is really starting to hot-up. It’s getting “juicy!”

I then read that Teina is going to start a new Political Movement which I suspect will be a loose collection of Independent candidates standing in various constituencies.

So it appears many voters could have a choice of at least 4 different candidates standing for 4 different political identities. Nothing wrong with that. The more choice voters have, the better quality MP’s we will end up with . . . I hope!

During the Easter Holidays, I received a number of “Political Intelligence Reports” from the islands in the Northern Group suggesting the following would happen if there was a General Election held tomorrow :

* Willie John would take the Penrhyn seat as an Independent.

* Apii Piho would take Manihiki for the Demo’s.

* Pukapuka would elect an Independent candidate because the people there have had enough of both the C.I.P. and the Demo’s.

* Rakahanga would go C.I.P..

So for the 4 Northern Group constituencies, the result would be as follows :

Demo’s: 1 MP.

C.I.P. : 1 MP.

Independent : 2 MP’s.

Such a result would throw the entire political situation in the rest of the country into turmoil.

Could it be possible that both the C.I.P. and Demo’s have their respective leaders defeated at the polls on 9 July?

You bet it’s possible.

So to avoid this, both men have a lot of work to do on their respective islands if they want to retain their seats in Parliament.

With regard to the other island constituencies of the Southern Group, I don’t think there would be any change if an election was held tomorrow.

All present sitting MP’s would be returned with Teina Bishop being elected for his Arutanga-Reureu-Nikaupara seat on Aitutaki as an Independent.

However, this could quite easily change in the coming weeks depending upon the quality and popularity of opposition candidates and what sort of political impact they are able to make in their respective constituencies.

So for the Southern Group seats, the result of an election tomorrow would be :

Demo’s: 4 MP’s.

C.I.P. : 4 MP’s.

Independent : 2 MP’s.

So for the 14 outer island constituencies, the count for an election held tomorrow would look like this :

Demo’s: 5 MP’s.

C.I.P. : 5 MP’s.

Independent : 4 MP’s.

The end result of an election held tomorrow would therefore rest fairly and squarely on the shoulders of the “Rarotonga Voters” and their 10 constituencies.

If the Demo’s don’t split once again in Ngatangiia and if the anti-C.I.P. factions in Avatiu can unite, then the Demo’s would take both seats from the C.I.P..

If the rest of the sitting members all held their seats with George Maggie taking Tupapa as an Independent, then the Rarotonga split would be as follows :

Demo’s: 6 MP’s.

C.I.P. : 3 MP’s.

Independent : 1 MP.

If one was to add all these seats together, our 24 seat Parliament would look like this :

Demo’s: 11 MP’s.

C.I.P. : 8 MP’s.

Independent : 5 MP’s . . . 24 seats.

We now have a “Hung Parliament”.

That above situation is what I see if we had a General Election tomorrow.

But of course we don’t. Much will change on the political landscape over the next couple of months.

So : “Expect the Unexpected to Continue”.

In particular, I will be looking at the Independent candidates standing and what potential impact they were making.

More than 2 Independent candidates standing in the same constituency will probably end up cutting each others throats.

Only time will tell.

On the other hand, we saw what happened in Ngatangiia and Avatiu last election where very strong Independent candidates did enough to split the vote sufficiently to determine the end result.

I wouldn’t be surprised if a similar situation didn’t happen in quite a few constituencies this election.

There will be a few surprises of “political twists and turns” as the campaign period progresses.

I expect a number of political surprises will fall completely “out of the blue” that could drastically affect a number of results in several constituencies.

What an interesting and “exciting” campaign period we are going to have over the next couple of months.

If I were to make a long term prediction as to which party or political group would win the General Election on 9 July it would be this : “Victory will go to those who are least expected to win”.

That is what happened in 1965.

There is something that can be done about it and that rests with the Business Trade and Investment Board (BTIB). They can exercise their legislated powers to defer any sale or transfer of TCNZ shares to Digicel until a full investigation has been done. Included in this process a Social Impact Assessment and an Economic Impact Assessment should be undertaken with submissions from the public.

BTIB are required to

undertake an in-depth due diligence on Digicel leaving no stone unturned independent of interference from Neves as he has tried in the past. Issues the landowners have been legally embroiled in with TCI should also be given priority attention and resolved before any Foreign Enterprise Registration is approved to the likes of Digicel.

Most certainly Neves and his cohorts from Crown Law will immediately start doing his jumping up and down drumming up fears of consequences and litigations. Neves and co should be totally ignored if he hasn't already been suspended by the PSC. Let Digicel litigate then discover they have been misled by Neves and Brown. No Judge will rule in favor of Digicel while there is a caretaker government. Added to that the due process for a Cook Islands business for sale was not done in accordance with BTIB rules. Retrospective

transactions are not accepted, so Neves jump up and down all you like, if the Board stands by their convictions and can repulse Minister Kiriau Turepu's compulsive political interference, nothing will happen until after the July 9 Elections.

WINDOWS XP where to now?

The end-of-support announcement has put some users into a panic, as it sounds ominous if you don't delve into the details. We've encountered users who think that XP will simply stop working, users who thought they'll be "forced" to upgrade, and users who believe troubleshooting XP will be virtually impossible after April 8.

The discontinuation of security patches is the most damaging part of terminating support for XP.

New attacks are constantly developed, but XP computers will no longer be receiving patches to counteract exploits. The operating system's security will degrade over time.

There's nothing you can directly do about this, but you can take security seriously. Make sure your Antivirus software is up to dates. Make sure your browser, as well as any relevant plug-ins (like Java), are constantly updated to their latest versions, and make sure you've backed up your data.

In truth, nothing will immediately change. End-of-support does not negatively impact existing XP installations in any way. No features will be disabled, no upgrades will be forced, and even technical support will still be relatively easy to come across. Literally millions of articles have been published about tweaking or fixing XP, and they won't disappear overnight.

New research begins on pearl quality

Manihiki pearl farmers stand to benefit from a shell cleaning trial conducted by the Ministry of Marine Resources' Pearl Support Division.

A six month trial of a new cleaning method, which so far shows shells grow larger the more frequently they are cleaned, is being undertaken by MMR Pearl Biologist Tina Weier.

The MMR team in Manihiki started the trial five months ago as part of ongoing research aimed at improving the pearl farming industry.

Weier says trials on virgin shells began to investigate the possibility of a stress-free cleaning regime for pearl oysters.

The shells are cleaned in-water, on the lines, by a SCUBA diver using a wire brush.

For the trial they took three groups of oyster shells, and cleaned them at 8 week, 4 week and two week intervals to compare against a control group that has been left uncleaned.

After four months, the shells cleaned at two week intervals are 7 per cent larger than the uncleaned shells.

Weier says larger shells contain larger gonads, so can produce larger pearls.

"The healthier the oyster the more nacre it produces – this is what gives the pearl its colour and sheen."

Typically oyster shells are set on lines for 12 to 18 months before they are cleaned and seeded. Farmers use hammers and chisels to clean shells, which can be

stressful on the oyster. The trial has found that shells can be left for up to two months and still be cleaned well with a wire brush. Pearl oysters must be cleaned of the fouling organisms that grow on their shells so they can get enough food and oxygen to grow. Weier says if oysters are covered in barnacles and other growth for too long, they are effectively being smothered. One oyster filters 624 litres of water every day to get food and oxygen.

If the water quality is low because of fouling and crowding, the more water they have to filter to get enough food, the more energy they are wasting and the less they have left for growing and producing nacre.

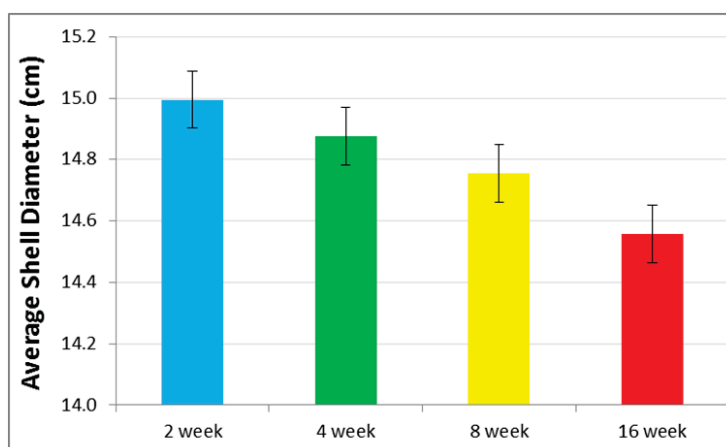
MMR is working with about 25 farmers to carry out other trials and are encouraging them to share their findings with each other.

Farmers are being encouraged to trial new techniques at seeding and harvesting times.

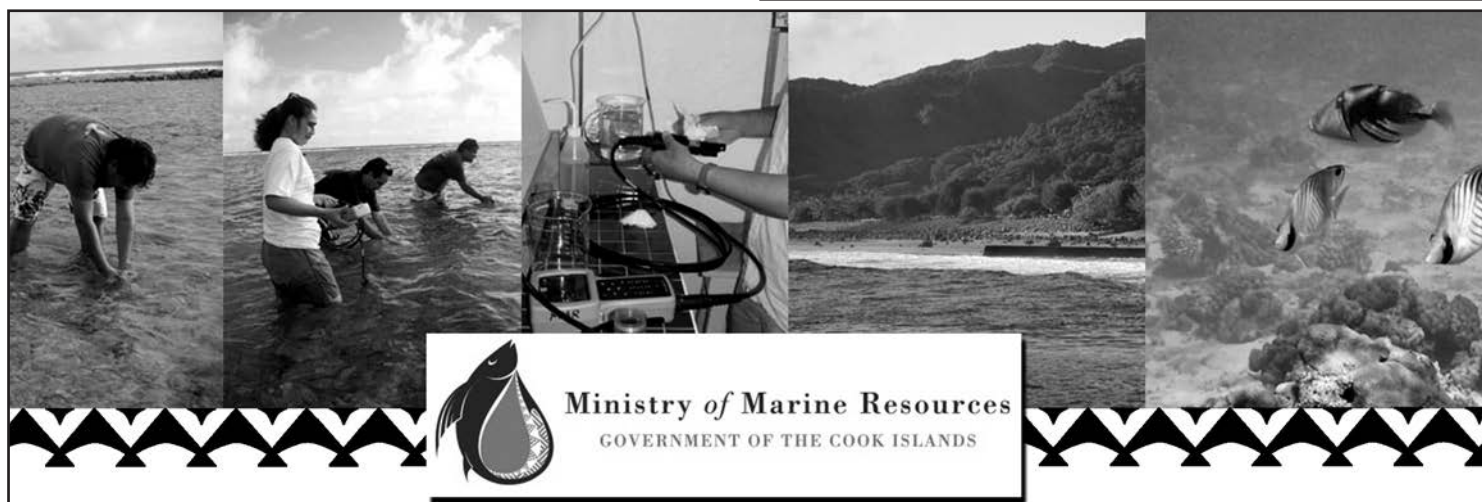
The riskier trials that have been proposed will be carried out on the MMR farm. Currently 1500 shells are being conditioned on the MMR farm for new seeding trials, some of which will look at pearl quality in younger oysters.

Weier says they are now conditioning 1500 shells on the MMR farm for new seeding trials. One of these trials will look at the quality of pearls produced from younger shells.

MMR will present the final results of the cleaning trial to industry members later this year.



The graph above shows the initial results of the shell cleaning trial after just four months on the oysters cleaned at two week, four week, and eight week intervals against the control group which was not cleaned.

Ian Karika Invested as Kamoe Mataiapo

Saturday 26th April 2014 marked the investiture of Ian Karika as the Kamoe Mataiapo of Ngati Kamoe. Since 1996, Ian had been the kauono of the Kamoe title, whilst his mother and previous titleholder, Rakera Karika, had been residing in New Zealand due to health reasons. Since then, the Ngapoko family previously met to discuss the plans for a title change over from Rakera to Ian.

Although the investiture of Ian Karika as the Kamoe Mataiapo, has brought up objections from the Ngati Pi branch, over who is the rightful Kamoe Mataiapo of the family, sister of Ian Karika, Helen Tatuava, tells the Herald that for eight generations the title of Mataiapo has never shifted from their line and so she is unsure of why the disruptions are occurring. For eight generations, the Kamoe Mataiapo title had moved through the descendants of Kamoe Manava, through to Te Arikatakatairangi, Kamoe, Te Upoko, Rakera, Ngapoko Kamoe, and Rakera Karika then to current titleholder, Ian Karika.

The genealogy recorded of all Kamoe Mataiapo titleholders was extracted from the official court documents on Rarotonga. From Ian Karika, the title of Kamoe Mataiapo will then move on to a descendant of the Ngapoko

Kamoe line, although it is too soon to select who will be next in line for the Mataiapo title.

Since the investiture, Ian has now become the eighth generation to hold this title within the Kamoe family line. In 1968, Rareka George Karika Kamoe had been invested in as the Kamoe Mataiapo, holding the title till 2009. Having been invested by Makea Nui Teremoana with the Potikitaua Mataiapo, Nono Manarangi.

Today the Kamoe Mataiapo, Ian Karika, was invested by the now Potikitaua of Ngati Makea, Anau Manarangi, at the Are Marama grounds in Tupapa, which is connected to the Arai Te Tonga Marae through the Are Roa land owned by Kamoe and Te Puretu. The title of the Kamoe Mataiapo has had long-standing ties with Ngati Makea, which comes under Makea Ariki, the Mataiapo to Makea Nui.

The duties and responsibilities of the Kamoe Mataiapo is to be the voice of his or her Ngati, to be headstrong in their role and ensure that peace through any family deliberations or issues that may occur within the Ngati will be found. Meeting with and making decisions based on the interests of his or her Ngati is also another duty that comes with the Mataiapo title, insuring that he or she protects the interest of their tribe, family and

The families of Ngati Kamoe believe that Ian Karika is the rightful person of the title, Kamoe Mataiapo. The fact that Ian has been the Kauono of the title since 2009 gives the family all the more reason to invest Ian as the Mataiapo. Within the community, he is recognized as a respectful individual who puts his island and culture at the heart of

his ambitions. For years Ian Karika has been an outgoing member in the community and is in many ways tethered to the cultural respects and ways of our ancestors before us.

Helen Tatuava believes that her brother will in many ways carry out his duty as Kamoe Mataiapo, with dignity, respect and honor. The family of Ngapoko Kamoe believes Ian will do an excellent job with the Mataiapo title.

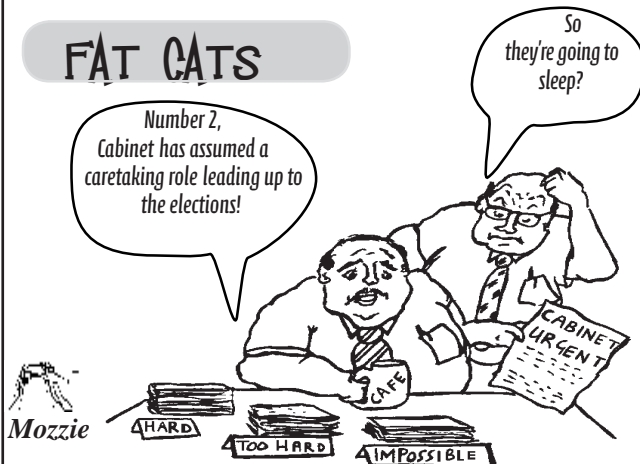

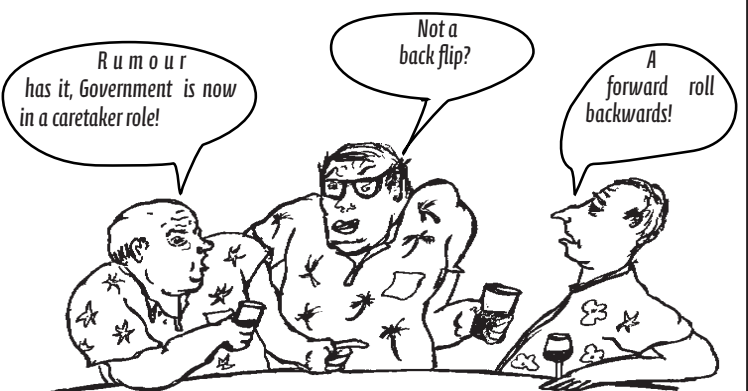

Chinese eating habits

We have experienced and adopted Chinese influenced dishes everywhere in the world including back at home. The two most popular “quick turnaround” chefs on the island that I remember are my brother “Funji” and my friend “Niu” at Punaga Nui. I remember my friend Niu’s kitchen opposite Raro cars. I usually enjoy his dishes and on most occasions I catch up with Mr Haupini at the spot. We would hold court on how to improve amateur boxing on the island, while waiting for our food. But now that I am in the heartland of Chinese cuisine, I can say with certainty that Niu’s menus are all hybrid and are more Cook Island style than Chinese. I now think that Niu has gone local without even realizing it!

This week, I will share my experiences with Chinese cuisine. The Chinese really do eat everything that is grown or that can move. I have made it my goal, to eat everything that we don’t usually eat back at home. I can say that the experience is always worth the risk. But then again, sometimes the challenge just blows my mind away. Coming to think of it, the Chinese will definitely think the same with our “ika mata”, though this comparison is mild compared to what I have experienced so far.

Like all cultures, eating is an important social event in China, and no celebration is complete without an accompanying feast. I use the word “feast” because even at a standard family dinner, there would be at least 3 different dishes for the family to share. There would be at least some soup, a dish that is made from just meat and one that is made from just vegetables. Alcoholic drinks are normally served at meal times too, be it just 1 bottle of beer or 3 bottles of wine.

For everyday meal time, all dishes are usually brought to the table at the same time and we use chopsticks to transfer food from the bigger plates (“communal plate”) to our own

individual rice bowls. At first I was taken aback by this practice (that there is no big spoon in the communal plate to be used instead of each person using their own chopsticks to get food from the communal plate to my own bowl). However an Australian colleague of mine (who is married to a local girl) jokingly said, “They use their own chop sticks at the communal plate to strengthen communal living and enhance family bonding”. Well, I guess that is true. Another common practice (which is a sign of endearment) is that the host or a senior member of the dinner party can get food from the communal plate and put it in your bowl to encourage you to eat the delicious food that is being served. This is normally done with the host or senior person’s own chop sticks ☺

Unlike the western world, Chinese tend to eat noodles or rice and some cooked dish for breakfast. However, the younger generations now opt for soya milk, a boiled egg and steamed buns (baozi), which copies the western breakfast.

Chopsticks play the most important role in Chinese cuisine culture. Like the west, where there is a particular way to hold the knife and fork, there is also a proper way of holding the chop sticks – which I did not master until after some months! Whilst the Chinese have a rich culture, many of these stem out from traditional myths and beliefs. It is taboo for you to put your chopsticks standing in your rice bowl because it looks like a funeral ritual of incense burning for the dead. Before I forget, rice at restaurants are free and you can get as many bowls as you want.

Like other countries, there are certain foods that are staple food for certain areas. The people from north of China tend to have bread (steamed or baked) with their meals while the people in the south tend to enjoy more rice with their meals. Sichuan province is known for tasty hot food. Chillies are part of the cuisine for the people in Sichuan. Sichuan is in the south central

of China and is well known as an earthquake prone province.

Zhenjiang (where the University is) is famous for its vinegar (which is eaten with everything – the same way we eat moinatai) while the current city that we live in now is famous for its fried rice! China is also famous for its street vendors, selling different types of food from pastries, grilled meat (pork, chicken, duck, beef, lamb and the like), rotis/naan bread, tofu (cooked in different ways), burger, fried noodles (we call “chow mein” outside of China: in fact this is a borrowed word from the Chinese “chao mian”. I also know that they sell Camels’ balls in Beijing and monkey meat in Guangdong (near Hong Kong), they are tasty!

Another famous food in China is the barbeque. However, this is very different from the barbeques we have at home. The Chinese also barbeque fish and vegetables and this is “grilled” over the fire. All the food that is grilled is put through skewers and is very

tasty because of the different spices that are sprinkled on the food whilst on the open fire grill. You will sure see a road side barbeque (within our city) after every 100 to 200 metres. The vendors in our city do not finish selling till well into the night. We have a few vendors on our driveway to our apartment (apart from the 6 different restaurants all housed at the ground floor of our apartment building) our favourite vendor is a husband and wife team that make barbeque till about 3 am. We enjoy their barbequed fish and mushroom.

Roasted duck is also a delicacy sold by restaurants and street vendors despite the fact that Beijingers (locals of Beijing) say that it is only a Beijing delicacy. There are also different types of crabs /lobsters that I have enjoyed and cooked in varying ways. They are very pricey however I have not been able to taste a coconut crab that tastes divine like the coconut crabs from Mauke.
