

## One Cook Islands to contest Mitiaro By election

declared a 50 all draw and a by election date to be announced, One Cook Islands Movement (OCI) is signalling their intent to contest the seat. The Democratic Party candidate is likely to be the 20 year veteran politician Tangata Vavia with the Cook Islands Party being represented by builder and surprise second time contender Tuakeu Tangatapoto.

Both candidates do not reside in Mitiaro therefore are unable to vote for themselves. The vibes coming out of Mitiaro is there is a strong preference for their Member of Parliament being a local resident in the cold face of the community.

OCI has confirmed an earlier indication to field a candidate in the Mitiaro by election.

While there was some interest prior to the 9 July Election after the snap election announcement in April, there was inefficient time and limited resources to field a candidate from Mitiaro. The lead time to select candidates before the closure of registration was very narrow and inadequate for the selection and preparation of a candidate. OCI did not exist prior to the April snap election announcement and reflected in only four candidates standing.

The outstanding polling results of the two OCI wins caught the attention and interest of fence sitting politically marginalised. One strong supporter of OCI described the Movement as a new birth that would need nurturing for a long life. Several times OCI spokesperson Aitutaki MP Teina Bishop said OCI was here for the long term with the objective of becoming government in their own right.


In the mean time with only two seats, OCI could still feature in government as a coalition partner. It's been no secret while the two major Parties have been

ith the Mitiaro seat embroiled in petition battles the OCI has been making hav while the sun shines, with preparations for the next elections kicking in straight after the Election results were declared, two months ago Bishop said, "People have seen our success and commitment being another political choice that has a distinct policy portfolio that separates from the sameness of the CIP and Democratic Party. > According to the Movement's President George Turia, OCIM is here to stay not with the intent of making up the numbers but to be the Government one day. "The two Party era is over, it's very clear the record result in Tupapa indicates the Rarotonga voter is looking for a change beyond swapping one party for the other," said Turia. "The writing has been on the wall for some time and the OCIM fits the bill of people's expectations and hopes, we are being proactive and will be preoccupied with our own development rather than wait around to see what the other two are going to do".

> The next phase for OCIM is to bring an administrative structure to the organisation, a Conference is planned for next year to confirm the known or selected candidates and two fund raising activities are also being prepared.

> Right now being fluid has its advantages but once the Rarotonga held Conference formalises the OCIM road map a major membership and policy awareness drive will be launched. Historically in Cook Islands politics, coalition governments have a limited shelf life with a budget on stability cautioned Bishop. "We are committed to honouring our obligations if we are a part of being government, but I can't speak for the others that's why OCIM will be election prepared and ready in quick

With the level of interest high from right across the demographic spectrum to the point of being over whelming, Bishop said,"we will be a serious contender, the advantage for us is that in a General Election, the outcomes are unknown and voters can be manipulated but in a by election the government is generally known so it is an influencing factor on the voter," said Turia, "but in the current scheme of things the only certainty of being in government is to vote for OCIM who will hold the balance of power".

Any opportunity to test the viability of OCIM is welcomed according to Bishop, explained as a new political identity; by elections was the means to establish a support base for future general elections. "Of course we will

be doing everything possible to win any by election we contest but failing that we will establish a foundation to build the movement, in Mauke for example, in a three way contest our candidate Tungane Williams polled 63 votes (32.6%) in coming second. This is a platform that we can build on for the next elections."

Concerning Mitiaro, OCI has a short list of three interested possibilities. According to Turia a by election for Mitiaro is a welcomed opportunity that has always been one of the scenarios that OCI have proactively been preparing for. "All three possibilities are candidate worthy but we will do our due diligence and select one of them for the long haul, it's just a matter who ticks the most boxes."

Turia said OCI candidate inquires and new members are welcome. - George Pitt

## Diversion for youth offenders

History was created Wednesday 24 September 2014 at the Sinai Hall when interested parties met at 9am and signed a Memorandum of Understanding (MOU) to create an alternative for youth offenders other than passage through a judicial system towards prison and be a diversion away from a possible career in crime.

In a nutshell, young offenders are to be given a second chance to turn themselves around thanks to a new initiative which enables the Court to divert them from the judicial system to a more community based system revolving around rehabilitation.

To be referred to this new system, youth must be capable of being rehabilitated as this will be a one shot chance to redeem themselves albeit under the guidance of their peers in the community.

Signing the MOU were the President of the House of Ariki, The Chief Justice, The Solicitor General, the Secretary of Justice. the Commissioner of Police and the Secretary of Internal Affairs.

As mentioned above, youthful offenders will now have a second chance to turn their lives around with support from those in the judicial and welfare systems including community groups such as traditional leaders.

This new diversion system which is along the lines of that in New Zealand, will be known as Te Koro Akaau and will be administered by the Ministry of Justice and will come under the legal frame work of the High Court and Children's Court.

What was noticeable at the signing ceremony for the MOU was the lack of members of the public. Those present seemed mainly to be public servants from the Ministries involved.

Details of the new system and how it will operate are set out below in the MOU.

- The Children's Court will remain the primary Court for dealing with Children and Youth Offenders referred to it by the High Court. Where a child or youth offender acknowledged his/her transgression he/she is then referred to Te Koro Akaau.
- The prime philosophy of Te Koro Akaau is to see whether the offender appearing before the Court can receive a discharge without conviction by having performed all aspects of a diversionary plan that has been agreed to at a Uipaanga Kopu Tangata (conference) and sanctioned and monitored by Te Koro Akaau.

## **Shell Shocked Demos** dithering over Leadership and election result scrutiny

ithin a few days of New Zealand and Fiji holding General winning Leaders are announced and activated but in tin pot Cook Islands a caretaker Government has been operational since mid April this year, the Elections on 9 July has come and gone and nearly five months later the country is in a governance void with restrictive spending powers not there is money to splash around except for frivolous travel by prodigal

The charade of High Court petitions dramas have served the Democratic Party well in that they mask their serious leadership deficiencies and an diversion to desperately avoid a Party Conference that will

put all leadership and Executive positions on the table and be contested. The Democratic Party is now suspended in a space of

compromised integrity regarding their Constitution; it is now over three years since the Demos have held a Conference that included position contestability.

Quick to claim the high ground on political morality and point the finger at the Cook Islands Party leadership for corrupt Constitution failure, the Eddie Drollet driven Demos under the Leadership of Wilkie Rasmussen have mirrored the arrogance of their opponents and failed miserably to project a defining difference between the two Parties.

With 24 hours of Labour David Cunliffe's defeat at the polls in NZ, his position was expected to be

reviewed and put back on the table. That process is now being implemented. Calls for Cunliffe to step down and an immediate evaluation of the Labour Party's defeat are being echoed throughout the Party, confidential Labour Party pre election polls are being demanded for the evaluation of Cunliffe's leadership.

Compare this with the losing Cook Islands Democratic Party (CIDP), an evaluation of their heavy defeat at the polls is the last thing they appear to want Constitutional amendment that to do. # Murienua Growers rally to launch agriculture initiatives

ne thing is certain, people eat and Cook Islanders love their food. In the Cook Islands particularly in the outer islands consumers are not spoilt for choice. There is very little variety in the way of fresh healthy fruit and vegetables. On Rarotonga the problems are not as obvious as they are in our outer islands but there is plenty of room for improvement.

Out west in Arorangi, Murienua Democratic Party MP James Beer is keen to develop agriculture and take the steps to change what he sees are necessary for community and national survival. Beer a long time agriculture tinkerer and hobbyist isn't prepared to sit around waiting for something to happen, armed with the accumulated knowledge of horticulture a subject he researches and trawls the internet for Beer says it's time to turn learned knowledge into practical experience.

Recently he met with a small group of farmers who are keen to get the acreage of Murienua and overall Arorangi that are lying fallow productive again, ' we had a growers meeting where the youngest of the growers was 57 years young, it is obvious that there is a dearth of younger growers coming through and this is a very worrying sign, the shining light out of all of this is that despite the age constraints of these growers they are certainly enthusiastic about production and simply want the support", said Beer. "It is exciting to see the synergies are there as is the commitment to corporate the beneficial outcomes to all contributors".

One thing we've got straight is dependence on government to set the direction and agriculture road map is futile, Beer said the private sector needs to drive the economic thrust with clear intent and frame work with a cohesive infrastructure before expecting government



assistance. "The country needs more than tourism and with the right agenda agriculture can make a significant contribution to the economy".

It is unfortunate agriculture isn't perceived by the younger generation as career options probably because its returns are labour intensive and irregular. Many are engaged in non commercial self sustaining planting as an after regular work hours necessity, but as permanent employment it's just not appealing.

The labour shortage is a real concern to the farmers said Beer. "If a new generation of farmers fails to mature, agriculture is destined to become virtually extinct". The new technology and the global expanse of things related to agriculture are phenomenal says Beer. "Embracing new practices and smart strategies will reduce

the hardship and significantly increase production".

Beer is convinced there is huge experiential library intellectual storage and combined with new technologies the local agriculture sector can become an economic bonanza with the reduction of imports and niche exports to New Zealand.

Immigration may need to come to the party and assist with imported labourers to allow the ageing planter demographic to be supervisors.

Beer has some firm ideas on where and how that support should come, "there is plenty of land ready for growing, so getting access isn't an insurmountable objective but finance and market accessibility along with regular expertise to assist in soil testing and pest control are areas where the greatest challenges exist.

Growers also want certainty, they live in a market where there is no consistency, prices fluctuate, and weather patterns rarely remain the same year in year out, it's either a drought or a flood. So having a national plan where they can expect some certainty at least from our government agencies on agriculture policy will go a long way towards giving our growers and their families the direction they need to get more heavily involved".

To keep farmers interested and to stay in the industry we need to have diversity in production and access to both local and international markets, if we can make growing exciting and rewarding we will go a long way to dealing with some of the biggest issues being faced today, like food security and youth non participation.

On the ground in Murienua James Beer has the following plans in place, the development of a seedling and fruit nursery coupled with a community compost station are areas that are being designed. The community has been asking for a nursery for some time and getting this up and running will be his priority in the next eight months.

"The community composting station is a good partner for a nursery, food scraps and bio degradable garden or yard waste will be shredded and composted, once we have the composting station completed which will include some heavy machinery




Emmanuel Rodriguez awesome time!" he says.






## Raui in Ancient times



ancient days, the n punishment for breaking a Raui was death or the lesser penalty of banishment from the tribe. The modern day Raui is a reworking of the traditional conservation tool used by the high chiefs of old, where they would declare an area to be under Raui or taboo, where nobody was allowed to gather any of the bounty of nature, whether on land or in the lagoon. In modern parlance, they were 'no-take' zones but in fact were more than that, they were also 'no-go' zones and the anywhere near the area at all.

Nicholls said the penalty of death was strictly adhered to and tells a legend of a man who broke the rules. The person took his canoe to one of the small motus and began fishing with the intention of heading back to the mainland before the break of dawn and thus avoid detection. After filling up his canoe, he noticed that the sun was beginning to rise and then to his horror noticed a war party of canoes coming toward him.

Knowing that his life was in danger, he rushed over to the marae on the island and offered all the bounty that he had to the gods. He fell to his knees and beat his chest and called out to the deities to save him. He called out that if the gods were there, to come and take their man. With that, a great commotion occurred in the lagoon and suddenly a huge blue marlin whooshed into the lagoon coming between the fleet of canoes bearing down

The marlin invited the man tribe were prohibited from going to come with him and the transgressor jumped on the marline which then swept out through the passage to the deep blue sea. The tumu korero said nothing further was known of the transgressor. I wondered aloud whether the transgressor had drowned in the ocean or whether he had been like the whale rider and had been saved? Whatever his fate, the price to be paid for breaking Raui in those days, was to forfeit your life.

## Showing fairness

part 1

his article is intended to encourage us to build our lives on one of the important values that have lasting positive impact on our lives which is "FAIRNESS"! There are those who ask the question of "Why should I be fair when everybody else is living for themselves, why shouldn't I just look after myself?" The truth is most people in society are not trying to be fair. They're thinking "How can I get what I need for my life the most?" The Bible is very clear that life itself is unfair. And because of sin, there is Unfairness! Injustice! The Book of Ecclesiastes in the Bible written by the wisest man who ever lived - Solomon. Solomon goes through life and looks at everything. Then he said, "Here's my conclusion. Life is UNFAIR." Then he gives five common occurrences of unfairness.

First, Solomon said that he noticed "People are being let off!" that CRIMINALS GO UNPUNISHED. Ecclesiastes 3v.16 (LB) "Throughout the earth justice is giving way to crime and even the courts are corrupt." From the time of King Solomon till now nothing much has changed. Many criminals don't get what they deserve. Ecclesiastes 8v.11 (NLT) "When crime isn't punished, people feel it is safe to do wrong."

This verse is so relevant for us today. Just watching what happens in the world on TV, in the newspapers, you can figure out three or four things:

- 1) If you commit a crime, it's very unlikely that you're going to go to jail for it. Given enough money, all you have to do is hire the right lawyer and they'll find some technicality charge.

you find out the verdict years later.

- 3) During that time you can sell your story to book writers and movie rights if you're in the United States of America especially if it's an interesting and highly publicized crime. e.g. a couple in Australia claim their baby was killed by a dog (dingo).
- 4) If you do get convicted, you probably will not serve a full sentence because of the likelihood you'll get off in a few years on parole and you can go out and do it again. Solomon says I see all this happening that criminals go unpunished and at the same time the victims and the victim's families suffer and that's not fair. And Solomon is right!

Secondly, Solomon says, THE OPPRESSED ARE NOT BEING HELPED IN THE WORLD. Eccl. 4v.1 (GN) "I saw all the injustice that goes on in this world. The oppressed were crying and no one would help them. Their oppressors had power."

Solomon is saying that it is human nature for human beings to try to dominate each other. One nation tries to dominate another nation. or one race tries to dominate another race, or the rich trying to dominate the poor, or the powerful trying to dominate the weak, and men trying to dominate women.

Even in some countries Christians can be killed for claiming to be followers of Jesus Christ. This normally is the trend almost every year around the world where thousands of Christians were killed! Solomon is saying this is not fair. And he is right.

Thirdly, Solomon savs. MANY RULERS OR PEOPLE IN AUTHORITY ARE UNETHICAL in the law to get you off the (CORRUPT). Ecclesiastes 5v.8 (LB) "If you see miscarriage of 2) Often it's going to be justice throughout the land, years before you go to trial. A don't be surprised! For every crime is committed and then official is under orders from

### higher up. So the matter is lost

in red tape and bureaucracy." One of the things about the

Bible is that it always tells the Ecclesiastes 10v.5-6 (GN) "Here is an injustice... Stupid people are given positions of authority..."

The Bible says when ungodly people hold positions authority they are going to abuse it and Solomon says that's unfair. And he's right.

Solomon Fourthly, PEOPLE says, GOOD GO UNREWARDED while evil people often prosper. **Ecclesiastes** 8v.14 (GWT) "Sometimes righteous people suffer for what the wicked do, and wicked people get what the righteous deserve!"


Solomon is talking about good things happening to bad people and bad things happening to good people?" It doesn't seem right. There are also times when dishonest people get promoted while honest people are overlooked. Solomon says that's not fair.

Have you ever been to a funeral of a good person, a young person and think, "Why did they die?" when you could think of a dozen other persons whom you'd rather see in the casket?

Solomon says in Ecclesiastes 7v.15 "It's unfair that some good people die young while some wicked people live on and on and on." And it's true.

Fifthly. Solomon savs. CAPABLE PEOPLE ARE OFTEN UNSUCCESSFUL. Just because you've got talent doesn't mean you're going to succeed. The good guys don't always win in this world. Eccl. 9v.11 (GN) "In this world fast runners do not always win the races.

Wise men do not always earn a living, intelligent men don't always get rich, and



capable men do not always rise to high positions." He says, "fast runners don't always win the race". Sometimes at the Olympic Games we hear stories like, "on the day of the race, they sprain their angle; or they have an accident; or they get the flu; or they missed the race because they were late." After all that effort they've put in training for years, something happens and they miss it?

Solomon says, "Intelligent people don't always get rich." In some cultures Boxers are paid more than what the Accountants or Chief Administration Officers gets. Even Rugby or Soccer players are paid more than the Teachers who train children. Solomon says, the bottom line is life isn't fair!

Solomon gives us five examples of what to do because of the unfairness of the life we live in! I will cover these in Part 2 of this article next week.



and more particularly Rarotonga.

6. As with the New Zealand models it is intended that this Court would involve, to a much larger degree than currently, the family of the offender and support for the offender and his/her family through government provided social services and monitoring agencies; advocacy either lay or professional or both; and community (village, oire, tapere, etc.) support through aronga mana and religious leaders. Most importantly, the opportunity for victims of offences to participate in the process must be made available.

**Operative Part** 

Entry into Te Koro Akaau

1. Child or Youth offenders' matters shall be referred to Te Koro Akaau after process in the Children's Court and High Court. The overall process shall generally be that set out in the flow diagram attached as Schedule A hereto (and as further described below).

**Judicial Officers** 

2. Justices of the Peace who are appointed under section 20 of the Act are able to preside in Te Koro Akaau.

Location

3. It is the intention that Te Koro Akaau will be convened in the Vaka where the youth offender resides and at such locations as are approved by the Registrar.

Frequency

4. As determined by the Registrar.

Who attends

5. Section 24 of the Act provides:

"Proceedings not open to the public -

- (1) No person shall be entitled or permitted to be present at the hearing of any proceedings in the Children's Court, save the following:
  - (a) Any officer or member of the Court;
  - (b) The persons immediately concerned with the proceedings;
- (c) The parents or guardians of any child in respect of whom the proceedings are taken, or any other person whom the Court may admit as the personal representative of the child;
  - (d) Any community youth officer;
- (e) Any person representing a social welfare agency engaged in work for the benefit of children;
- (f) Any other person specially permitted or required by the Court to be present.
- (2) Save with the special consent of the presiding Judge or Justice, it shall not be lawful for any person to publish a report of any proceedings taken before a Children's Court; and in no case shall it be lawful to publish the name of any child, or any other name or particulars likely to lead to the identification of the child.
- (3) Every person who commits a breach of the subsection (2) of this section shall be guilty of contempt of Court, and shall be liable accordingly and in addition shall be liable on conviction to a fine not exceeding two hundred dollars."
- 6. It is envisaged that people permitted under s24(1)(f) shall include, but not be limited to, Traditional Leaders, Vaka/tapere Elders and any other person whom the Court considers able to assist in the resolution of the matter before it. Rights of address shall be as determined by the presiding judicial officer.

Role of the Ministry of Justice

7. The administration and operation of Te Koro Akaau shall be the responsibility of the Ministry of Justice.

Relationship of Te Koro Akaau to conventional court

8. Te Koro Akaau operates and exists within the legal framework of the High Court and Children's Court.

Uipaanga Kopu Tangata (Conference)

- 9. Purpose of Conference:
- (a) Any Conference must:
- (i) discuss the circumstances of the offending; and
- (ii) seek the views of those in attendance; and
- (iii) consider whether a reconciliation or other outcome may be arrived at by the parties affected.

- (b) A recommended outcome may include payment to any victims for reparation, property loss, medical expenses incurred or any other reasonable loss suffered by the victim as a result of the young offender's actions.
  - 10. For the avoidance of doubt:
- (a) There may be one or more Conferences as required in each case;
- (b) The individual file may be referred back to the Children's Court at any stage if it is no longer appropriate to utilise the procedure recorded in this MOU.
- 11. Principles to consider at a Conference. Any recommendation determined at a Conference shall have regard to the following principles:
- (a) The accountability by the young offender for the wrong that has been done;
- (b) The rehabilitation of the young offender including an assessment of the suitability of his or her current living arrangements;
- (c) The involvement of the young offender's family, church, chief, and village:
  - (d) The protection of the community;
- (e) An acknowledgement of the views of the victim and to restoring the position of the victim in accordance with the Cook Islands custom and tradition;
- (f) The putting in place of a plan for rehabilitation of the young offender that fosters responsibility by the young offender and which promotes the young offender's self-esteem, cultural awareness and understanding.
- 12. The Community Youth Officer is to chair and then record any recommendation agreed at the Conference.

Guide to procedure

- 13. Te Koro Akaau shall be convened once there is a rehabilitation plan (containing a recommendation) agreed at the Conference.
- 14. The procedures of Te Koro Akaau should be along the following lines:
- (a) Judicial Officer already seated at bench, with Traditional Leaders Representatives, Social Worker, Community Youth Officer, Probation Officers, victim and Police already seated before young person and his support group enters the court area and sits with lay advocate and lawyer;
  - (b) Elder speaks and offers a prayer;
- (c) Judicial Officer introduces self and young person introduces family/supporters to judge;
  - (d) Rehabilitation plan (plus recommendation) tabled;
- (e) Direct discussion between Judicial Officer and young person to discuss reason for appearance, monitoring and progress. Up to a 40 minute very interactive discussion and quite personal;
- (f) Youth advocate speaks and refers to report and tasks undertaken and those yet to be undertaken
- (g) Lay advocate speaks on how relationship with young person has gone and offers insights into personality/character;
- (h) Judicial Officer offers victim the opportunity to address the court/gathering (if needed);
  - (i) Social worker invited to comment;
- (j) Judicial Officer invites family or other community support to comment;
- (k) Judicial Officer asks police to comment especially as to disposition for instance a section 25 discharge or section 26 Supervision Order;
- (I) Judicial Officer offers young person the opportunity to address the court/gathering;
- (m) Judicial Officer discusses next event or, if all tasks completed, disposition;
  - (n) Closing prayer and address by elder;
- (o) In the event of a discharge a ceremony is undertaken and, if appropriate, a song is sung.

Commencement

15. It is envisaged that the commencement of the Te Koro Akaau be on or about 1 October 2014.
