## Te Mato Vai has it all - political interference, shoddy work, unpaid damage bills, strife between working Groups

### Warnings coming home to roost

o-ordinating the components that contribute and make up the construction of the multimillion dollar Te Mato Vai (TMV) project is slowly becoming a headache that has no end in immediate sight. As the Chinese contractors China Civil Engineering and Construction Corporation (CCECC) roll out their construction they do so at the irritation and peril of others. Highly resistant to compliance requirements of the quality control standards CCECC are becoming difficult to reign in.

Rumours surfaced last October that CCECC wanted KEW Consultant boss Latu Kupa replaced as the Project Manager due to incompatible views on the quality of the work being delivered by CCECC. This year a TMV media release announced Kupa was being replaced in a sideways rearrangement in KEW. Kupa will be based in New Zealand involved in other KEW work but would make periodical visits to Rarotonga for TMV related business.

The TMV Construction Work Stream (CWS) which includes representatives from the utility services want an immediate clarification of CCECC's and governments scope of responsibilities under the ring mains upgrade contract. Te Aponga Uira (TAU) has had instances where CCECC would not take responsibility for damaging power cables in the course of construction works, stating they (CCECC) are not responsible and it is Government's responsibility to take care of such matters. half, TAU are yet to recover the remaining half. In November due to digging too close to a power pole resulted in the pole collapsing. Due to safety issues the pole was immediately shifted to the opposite side of the road and cables re routed at a cost of \$6000 which CCECC has refused to pay.

In many cases members of the group believe their organisations are being unfairly afforded responsibility by CCECC when the contractor does not wish to claim responsibilities for their own actions. In other instances CCECC have tried to pass off responsibility for road reinstatement and traffic control on to T&M Heather as if they were a separate party in reality the (T&MH) are CCECC's subcontractor, thereby making CCECC responsible for all their actions.

The CWS Group would also like to clarify the level of authority CCECC has under its contract, the group members would like to know how a government contractor (CCECC) is able to engage government Ministers to intervene on their behalf when there is a situation that is not suitable to the Contractor, does the contract allow for special circumstances?

In this instance when CCEECC wanted to continue working during the Christmas period, Minister of Finance Mark Brown and Deputy Prime Minister Teariki Heather acting on behalf of CCECC tried to exert pressure for acceptance of CCECC 's work demand. Latu Kupa of KEW Consultants intervened and closed down the work over the Christmas period due to their absence to have holidays. It's no wonder CCECC lobbied to have Kupa replaced.

eputy Prime Minister Teariki Heather who is also Minister of Infrastructure Cook Islands (ICI) and is the owner of local contracting company T&M Heather has notched up another sweet heart Chinese related deal this time in excess of \$50,000. With the arrival of the Claytons \$6.5 million freebie of heavy duty machinery from the Peoples Republic of China (PRC). That machinery had to be physically moved from

the wharf due to the lack of Ports Authority storage space. T&M Heather Ltd was engaged to move the machinery by truck and trailer three times including to T&M Heather's Arorangi yard at a cost of up to \$500 a move per machine. The lastest move was to the reclaimed land on the seaward side of the Punanga Nui Market. The total payout most likely close to \$60,000. Knowing well in advance of the arrival and logistics

of storage for the machinery the moving contract was never publically advertised. No excuse can be used to justify that this contract was unexpected and needed to be executed urgently. Cook Islands General Transport who says they were unaware of the job could have been offered half of the work. Once again this raises questions of conflicts of interests by Minister Heather.

Their minutes state, Construction Work Stream were not satisfied with response given by Legal Work Stream in regards to Contractors access to private land on the Stage1 Ring Mains Upgrade works. The CWS would like an explanation from the Legal Work Stream as why they have not done more to facilitate the difficulties faced by the Contractors and Utilities in addition to a statement from CIIC detailing their involvement in the Legal Work Stream as some of the CWS are not satisfied with the decision making and output coming from this work stream. The Group would like the matter to be raised at the Project Steering Group level if not improved. - Georae Pitt

# Rasmussen losing grip as gloves come off in fight for Party control

Raro Cars staff are being invoiced to pay a parking fee of \$3.50 and some are upset because they claim no signage exists warning the public against parking on the wharf.

Staff also guestion if members of the public who park in the same area on Saturday when visiting the Market, are also charged a fee.

#### **Comments by Ports Authority CEO**

Ports Authority CEO Bim Tou advised the Herald on Tuesday morning that Don Carlaw of Raro Cars (across the road) had been contacted about his staff parking their vehicles on Port Authority property and in the spaces where Port Authority tenants clients would park. Raro Cars staff he said, parked their vehicles in these areas for lengthy periods. Tou said there are several signs up warning persons about parking.

Tou said under the Ports Authority Schedule of fees and charges there is a fee for parking by persons who are not tenants of the Authority. This is the fee the Ports Authority is charging Raro Cars staff.

Tou also said tenants have complained when their clients cannot find a park because Raro Cars staff have parked in the area.

Other members of the public should also be wary about parking their vehicles for extended periods on Avatiu wharf especially in areas around the Ports Authority building, the building where Taio Shipping is based and John Scott's retail shop unless of course you have some business with these establishments.

## 2015 minimum wage review

n accordance with the Employment Relations Act 2012, the Minister Nandi Glassie, has confirmed a Minimum Wage Review Panel to conduct the 2015 review the current minimum wage rate in the Cook Islands. Panel members include Patricia Tuara Demmke, Ministry of Internal Affairs; James Webb, Ministry of Finance & Economic Management; Steve Anderson, Chamber of Commerce (for employers); Anthony Turua, Cook Islands Workers Association (for employees); and Nga Mataio, community representative appointed by the Minister. The task of the Panel is to review the minimum wage rate and make recommendations to the Minister who will then decide on the current rate. Factors such as prevailing economic conditions, income distribution, protection for low income earners, and work incentives, as well as public submissions will be considered when the Panel carries out the review. In 2006 the minimum rate was set at \$5.00 an hour. In 2014, following the review, the rate was increased to \$6.00 an hour. a 20% increase on the 2006 minimum wage rate. The Minister is looking forward to working with the 2014 team once again, and also been a Board member on welcomes new panel member Nga Mataio.

## Much to offer in Qatar

The Government of the State of Qatar has taken great steps into subsidising transport in an effort to reduce the congestion of traffic, especially at peak hour in the city. It has launched a shuttle service by the name of West Bay Buses which travels all around the city, making a stop every fifteen minutes. The media have been given the privilege of using this shuttle service as a means of travelling between destinations, which is both efficient and convenient. Although there is plenty of parking space available in the Cook Islands and traffic

congestion is not a threat, the Cook Islands government should consider subsidising at least a quarter of public transport. In 2010, a school bus ticket cost thirteen dollars. Almost four years later, the same bus ticket now costs \$15, which could be spent in other areas such as lunch money or stationary supplies.

The fashion is quite modest, as it has always been in most Middle-Eastern countries. Qataris take great pride in their traditional attire. For the men, they wear a long, simple shirt with loose pants and a head dress called a gutra, which can be in red or white cloth, fastened with a black rope called an agal. For women, the hair is covered with a black head dress called shayla worn with a blacked dress called an abayha. Their faces are sometimes covered with a black

cloth called bourga, however, this is entirely up to the wearer. Although, it has been discovered that adjustments can be made to suit your tastes. Women have opted for more bold choices, changing the traditional black for a more modern beige or neutral. There is no shortage of handbags either, ranging from exclusive brands such as Gucci and Louis Vuitton. Sunglasses are also necessary, not only protection against the for glare of the sun, but to remain fashionable. The Qataris sense of style is simply quite stunning.

The level of technology is also very impressive. Everyone seems to keep up with the latest trends not only in the fashion industry, but in electronic devices as well. The newly released iPhone 6 and Samsung S5 are proudly flaunted by businessmen all around. They not only use these gadgets for the basic text and call, but to set up meetings with business partners half way across the globe. Social networking is also a popular feature here in the city. There is a common misconception that Middle-Easterners are traditional to the point where they do not appreciate the modernday lifestyle, but that is not the case. Technology evolving in this country seems to have no boundaries, as the average consumer is constantly on the lookout for the latest update to their phones. Modern day technology has been integrated into the lives of these people and they have certainly made the most of it.

# **It's a no brainer really** FAO/DCD Case Study 1 – Agriculture related

n a wall inside the kitchen where the staff of the Pacific Resort at Muri prepares all the food for their guests, there is a white board. On it is a list of all the products they would like to source locally. It shows the name, the quantity, and how much they will pay. The list is deliberately displayed in an area where people bringing supplies to the resort will be see it and can take note and maybe deliver the goods.

For more than a decade the resort has been working proactively with a few growers for products on that list, and takes pretty much all they produce. But it's still not enough.

They have begun working with a collective of growers too, to try and get more local foodstuffs. But the message that we want this, in this quantity and at this time, seems to be a hard one to get across. Many of the island's growers have got into a rhythm of their own, growing this crop at this time, never mind what the market may want.

So despite best efforts for over a decade, Pacific Resort at Muri is meeting only 16% - by value - of its food needs from local growers; local fishermen get about 7% of the food budget. On Aitutaki the percentages are slightly higher with the growers on 20% and the fishermen on 10.

So out of an annual food hill of \$1.2million about \$300-thousand goes directly into the hands of local growers and fishermen, the rest goes offshore via local importers.

Greg Stanaway the CEO of the Pacific Resort Hotel Group says he would really like to see far more product from locals. He says local foods are fresher and more nutritious.

With greater and more regular supplies he would make a feature of the local food in the resorts restaurants.

The encouragement Pacific Resort gives to local growers goes beyond just having the cheque book ready, the resort has extensive and well-established gardens and every scrap of green waste from them is taken to the

Titikaveka Growers Association to change too. to produce mulch for their organic gardens.

The visitor industry is the biggest money earner and employer in the Cook Islands. The biggest group of visitors who come here are from New Zealand. Trade figures between New Zealand and the Cook Islands show we do about \$98-million worth of business a year. Products we export to New Zealand – mainly fish – are worth about a million a year. But we import \$97-million worth mainly food - in return.

A United Nations Food and Agriculture Organisation (FAO) representative spent who some weeks here at the end of last year, identified what Greg Stanaway already knows, that there is huge potential for the fledging agriculture industry to supply fresh produce – including iuices - to the local market, not just for the visitors, but to locals as well. And that by replacing a lot of the imported processed foods and things like soft drinks, the country would save overseas funds and end up with better health outcomes too by eating healthier tucker.

Food security is a big issue the for countries around world. That's why Chinese entrepreneurs are buying up dairy farms in New Zealand so they can lock in a source of dairy products into the future. It doesn't seem such a big issue in Rarotonga when all the fruit trees are loaded, the fishermen are still catching fish and there are plenty of little pigs growing up ready for the umu. But as the figures show the millions of dollars worth of processed foods we import from elsewhere leave us vulnerable should others tie up those supplies, or if prices begin to soar.

Most resorts don't bother trying to buy local, it's easier to call the importers and wholesalers and place an order. That way you get what you want and when you want it.

If that's to change and we increase the consumption of local food, the supply side needs

The FAO stated the obvious that most growers are getting on in age, and they have been doing certain things in a certain way for years. The industry needs new blood. At the moment regardless of how low wages are in the tourism industry they are better than working for very little out in the hot sun all day. As one local businessman told me 'agriculture needs to be made sexy'. The FAO stated the obvious again, that the land available for increased production is a problem. Holdings can be small, not much bigger than family plots, whereas a more 'industrial' approach to production is required.

Agriculture needs a 'champion' a leader, is there anyone waiting in the wings?

Resorts need to see the value in serving local foods and talking about it to their guests, and begin developing growing and purchasing arrangements with growers.

In the beginning the Pacific Resort used to pay its selected growers upfront for the produce they wanted. Now that those growers are on their feet, weekly payments are the norm.

Growers will need help to step up, but they have got to make some changes too. Some have been mesmerised by the retail prices paid for pawpaw and other products in New Zealand, and have channeled their efforts into trying to export. But they've shut their eves to the 'costs' of getting those products to a market 32-hundred-kilometres away, and there are plenty of stories of people ending up with a 'bill' not a cheque, at the end of the exercise. And they need to attract younger people into the industry.

Greg Stanaway wants to see about a quarter of his food bill heading into local growers pockets.As small as 25% local seems, it would still require almost twice as much product as he currently gets. He also happens to have a couple of radical suggestions to help make that happen.

He thinks that somehow, the land tenure system needs to be

changed to allow more land to be brought into production; and he thinks we need to import labour used to working largescale gardens. He thinks they should probably come from China and/or the Philippines. He knows that will be controversial but he says the workers should not be considered cheap labour and they should be paid maybe double the current minimum wage; and they should come here under a fixed contract and visa arrangement - say two years with another two maximum, and they should train locals to take over from them while they're here.

This year these islands are marking 50 years of selfgovernment.

Fifty years ago almost no food was imported, today from one country alone - New Zealand - we import getting up to a hundred million dollars worth of products, mainly food and drinks; and that's just one country.

Each year Cook Islanders wave goodbye to scores of their family heading off on the big jets, mainly to New Zealand; sometimes forever. Many are young, just the sort of people you want to stay and keep building and serving the nation. Fifty years ago a handful of Cook Islanders lived in New Zealander. The latest New Zealand census shows there are now at least 62-thousand.

Ramping up local food production will provide jobs, better food and juices for the visitors and the locals, and much healthier outcomes for locals too

There are obviously a number of ducks that need to be lined up to get the outcomes being suggested above, but lining up those ducks could be one of the most important things a Cook Islands government could do to set the country up for the next fifty years. Tourism, as vulnerable as it is as an industry, is set to be the main source of jobs and income for the forseeable future. Healthier food, healthier

outcomes, local food for tourists, fewer imports and jobs too they all seem like no-brainers really.

The FIU function is to facilitate the prevention, detection, investigation and prosecution of money laundering, the financing of terrorism and other serious offences in the Cook Islands.

### What is the purpose of the project?

The purpose of this project is to provide all inhabited Outer Island Governments with functional heavy plant and machinery that is adaptable to local environments.

One of the main challenges is the distances between the inhabited islands and their distance from our main economic and administration centre on Rarotonga (e.g. Mangaia 176km & Penrhyn 1395km distance). Government is committed to ensuring that all these islands maintain a viable and sustainable community and has already funded major infrastructure upgrades to harbours, water and energy systems with more planned over the 2013 – 2016 period and highlighted

in the Cook Islands Capital Plan released with the Annual Appropriation to Parliament.

The aim is to provide suitable plant and machinery for the Outer Islands to assist the Island Administration to undertake various projects to support development. Infrastructure underpins most of this economic growth and functional plant and machinery are needed to sustain it. This includes essential services such as cyclone recovery, off loading cargo, airport maintenance, road maintenance and supporting agricultural plantations.

### What agreement do we have with the Peoples Republic of China?

Peoples Republic of China (PRC), with a view to and the Government of the Cook Islands signed on further developing the friendly relations and economic December 14th 2005, April 5th 2006 and February 20th and technical corporation between the two countries, 2008. have signed various Agreements on Economic and Technical Cooperation. These Agreements document The PRC are responsible for the delivery of the pledges of grant funds by the PRC to the Cook machinery to Avarua and will dispatch technicians to Islands.

This project shall be paid out from a grant under the Agreement of the Economic and Technical

## **Dramatic change since 1965**

s the first of the major theatres international meetings marking 50 years of selfgovernment for the Cook Islands is about to get underway next month, the Minister of Finance -Mark Brown - says he has found it remarkable to look back at the development that has occurred and the changes that have taken place in his life time.

"I was two years old in 1965 and the Rarotonga I grew up in has changed dramatically. Back then there were no sealed roads. There were very few cars, there were some motorbikes, which were what every young man aspired to owning - but most people walked.

We walked everywhere. 1 remember the two picture then.

being packed out showing double features and after the pictures people walked home.

The airport was still a grass runway where piston and turboprop aircraft landed from time to time.

The two harbours were where we kids used to swim, and when boats came passengers and cargo were still brought ashore by lighter.

Most of the kai we ate was locally grown and produced; imported food was a luxury. Our treats and 'lollies' were local fruit. I despair when I see the fruit on loaded trees just left to rot or fall on the ground.

I remember large cultivations of oranges, which sadly have all gone now

So there have been big changes even in my time. Back then the schools were very basic, but it was a privilege to go to school, and at the end of the day we tidied up our school. Our education system has changed immensely since

So has our health system. I it was very rare to see a local in remember when the doctor used to travel round the island and if you or someone in your family was sick you hung a nappy or cloth out and the doctor would know that someone needed attention and call in. The medicines available now far far out number remedies available back then, both in quantity and quality.

By the time I left to further my education in New Zealand in 1981 the international airport was operating and tourism was starting to grow.

It was a big deal then to catch the big jet. You dressed up in your Sunday best; none of this turning up in shorts and jandals. And there was a big crowd to see you off or come home.

is in Luke 6v46-49 which is The Parable of the Two Foundations. Jesus through this parable is showing the difference between the wise builder and a foolish builder, and what to do and what not to do. He also teaches us the importance of establishing the right foundation and how to apply this to our lives.

why do you call me Lord, Lord and do not do the things which I say?" The first lesson is to be doers of the Word. In Matthew 7v.21 Jesus said "Not everyone who says to me 'Lord, Lord, shall enter the Kingdom of Heaven, but he who does the will of My Father in heaven." In order to establish the right foundation, we need to translate the hearing of God's Word into action.

Secondly, we need to fully understand that Jesus Christ is the only true foundation. Jesus said in Luke 6v47-48 "Whoever comes to Me and hears My sayings and does them, I will show you whom he is like: He is like a man building a house who dug deep and laid the foundation on the rock. And when the flood arose, the stream beat violently against that house and could not shake it, because it was built on the rock." In Psalm 62v2 David said "God alone is my Rock and my Salvation. He is my Fortress. I will never be shaken." Unless we establish Jesus Christ as the foundation of our lives, we will be unable to stand secure and unshaken when the pressures of life mount up on us.

Thirdly, we need to be willing to work. Luke 6v.49 reads "But he who heard and did nothing is like a man who builds a house on the earth without a foundation against which the stream beat violently and immediately it fell. And the ruin of the house was great." The reason why

this man builds upon the sand he main scripture reading was because He didn't like hard work. He could not be bothered to take the time and make the effort to digging into the rock and make a strong foundation for his house. The sand was much more attractive and less work. This man was just not willing to work. He just wanted to concentrate on living rather than building up. Sad to say a lot of Christians and also people Firstly, in v46 Jesus said "But are like this. If this man had exercised wisdom he would have build a good foundation by digging down to the bedrock. Then his house would have been safe and secure when the floods came

> The path that follows Jesus Christ leads to security, both here and in eternity. If we are going to make Jesus Christ our foundation, then we need to be willing to work. The Apostle Paul in I Corinthians 15v.58 said "Therefore my beloved brethren, be steadfast, unmovable, always abounding in the work of the Lord, knowing that your labour is not in vain in the Lord." There are no shortcuts in God. If we are going to establish the right foundation in our lives, we need to be willing to work hard. "No pain, No gain" We must be willing to sacrifice time, finance, energy and even resources. We must be willing to sacrifice whatever it takes, to have the right foundation who is Jesus Christ established in our lives. Galatians 6v.9 reads "And let us not grow weary while doing good, for in due season we shall reap if we do not lose heart." We need to be willing to work.

> Finally we need to have a long term vision. Luke 6v.49 tells us that after this man had build his house upon the sand without a foundation, the flood came and the house collapsed and was destroyed. The reason was because he made two important mistakes. Not only

was he avoiding hard work, but he was also short sighted. In other words, he didn't have a long term vision. This man never stopped to think what would happen in a few years time. As long as the weather was steady and the sky remained blue, there's nothing to worry about. And in Palestine it's not until 7 years after that another flood is expected. His motto is "Don't worry be happy" the Boys Brigade motto is "Sure & steadfast!" Girl Guides - "Be prepared!" 
