

# Timing of Outer Islands Council elections orchestrated by CIP

Once again the Cook Islands Party government shamelessly parade their blatant disregard for convention. The timing of the ten island council elections in the Pa Enua is just another case where the Henry Puna administration is manipulating the process and the polling date. There is a process that determines the timing of the elections but that has been ignored to fit the government's strategic vote obliging schedule being rolled out.


At the fore front of the CIP drive to politicise the local body elections is the Deputy Prime Minister Teariki Heather. This coming election is another stepping stone opportunity in his persistent determination to become the Leader of the CIP. Heather wants to hand pick CIP candidates for Mayors, people who will be loyal to him in a CIP leadership vote.

For the sake of social harmony the harsh divisiveness of Party politics in Council elections of the small Pa Enua communities has been kept at bay and discouraged but Heather intends to get CIP supporters in positions of power and influence ready to fly the flag when the next general elections are held.

The excuse floated by the government why there has been a delay in the elections is because the people asked for the delay. Is this another one of the PM's fabrications like the Manihiki landowner's extortion threats? Other excuses simply don't hold water; it's been six years since they were last held and the elections in March are being timed to strengthen the CIP's strangle hold of their power base among the 14 outer island constituencies.

Harbours have been upgraded, pearl farming grants plus pearl equipment delivered, solar power installations established, heavy machinery courtesy of the Peoples Republic of China (PRC) have been barged to the respective islands, the proposed fishing grants, national TV broadcast now a reality, the New Zealand Army engineers have been engaged to assist with projects and the icing

on the cake, the impressive PRC agriculture machinery. The southern group solar installations are about to be commenced not to mention the proposed airport upgrades.

The CIP has piggy backed on the millions of dollars of donor aid funding as it was their own raking up huge deposits of political credits while the paralytic Demos are oblivious to what's happening under their noses. The CIP strategy of creating voter obligation may leave a sour taste in the Demo mouth, but that's because they don't have a strategy to capture the Pa Enea seats.

In the 2014 general election the CIP campaigned on their work accomplished up to date with promises of more to come and they have delivered beyond expectation.

As good as the policies of the Democratic Party are they simply don't have a strategy to turn them into voting attraction. As long as the Demo failure specialist Eddie Drollet grinds the organ there will be no strategy forth coming, "it's in the bag" isn't a strategy.

The Pa Enea elections can now proceed as a feeler to test the popularity and pull of the government. When Puna pulled the plug and went to the polls early, he was entering the political fray from a position of weakness yet won a perceived unwinnable contest. The overconfident Democratic Party lost the last elections because they didn't have a strategy to win outer island seats, there was a misguided presumption those seats were in the bag.

If the CIP government's election candidates pull the voters then that will give Puna's team the confidence in the option to go back to the polls for a snap election. If the coconuts fall the wrong way for the under investigation Mona Ioane MP for Vaipae/Tautu then Puna may have good reason to pull the plug while the Demos are anchored with indecisive leadership and paralysing debts.

This is the reason for the delay in the Pa Enea elections, the elections are being timed to gauge the political pull results

of the benefits channelled their way. Last week, despite there being four Ministers present, as the Acting PM, Heather cancelled Cabinet

without reason. At mid day on Friday 5 February, Ministers, MPs and Party Executives were summoned to his Nikao residence where he took centre stage and promoted his agenda for the Pa Enea elections. Following his chest beating exercise the food and drinks were laid on.

There was no doubt Heather was the X factor in the Pa Enea during the 2014 general election, the platform he created then is to be his launching pad to elevate his leadership stake during the council elections.

Unfortunately the DPM Heather will not revel or enjoy the harvest of his labours. Heather has tirelessly made every effort under the guise of Infrastructure Cook Islands (ICI) to get out there and promote himself as the real benefactor of their good fortune. Heather has embarked on a personal campaign to convert the hearts towards him. As Absalom did it to King David, so Heather is doing it to his PM.

Puna is stuck in a rock and a hard place, he is forced to yellow card his Deputy out of cabinet and withdraw his Ministerial portfolios. Heather is officially under investigation over alleged corruption related to a bobcat purchase.

The Cook Islands constitution, article 14, 7(b) is very explicitly clear on the PM's statutory obligation. The supreme law of the land requires Heather to be relieved of all his Ministerial

responsibilities. While Puna may give the impression he is reluctant and his hand is being forced he will be inwardly satisfied he has clean hands,

retribution.

There will be denials and rebuttals from the government that there has been closed door discussions on the fate of Teariki Heather, at the moment Matavera MP Kiriau Turepu is the front runner to become the next DPM with Mark Brown the Acting PM in the absence of Puna.

Allegations of corruption against the bombastic Teariki Heather that have initiated the Financial Investigation Unit (FIU) investigation are very serious and at worst could result in the DPM being handed a red card followed by him serving a custodial sentence.

Should the Heather investigation by FIU become too politically messy and with resistance from within the CIP camp to return to the polls, Puna has the numbers option of negotiating a welcome back Kotter arrangement with One Cook Islands and former CIP MPs Teina Bishop and George Maggie who will come at a high price. - George Pitt



Rarotonga is becoming a litter bug heaven thanks to some people who are plain clueless, have no shame and expect others to clean their mess.

Too many people are taking our environment for granted, as seen by the appalling man-made debris which litters our beaches and inland streams. Matthew Rima, a representative of the National Environment Service, has made a plea to the general public on proper rubbish disposal.

"We are very concerned with this issue, as it can lead to detrimental effects on our environment," Rima says, whilst

pointing out to the debris inside an Arorangi stream. There has been a central focus on the residents near the inland streams who do not adhere the right procedures with regards to the disposal of their rubbish. "The main problem which needs to be addressed is people not containing their rubbish on the burning site." He goes on to explain that if no further action is taken, the debris will continue to flow into our oceans and affect our marine life.

Rima and his team at the Environment Service have been campaigning for the past three years, urging the general public to clean up after themselves. "Many of our school students

end up collecting the rubbish which lies on the coastal area, when it really shouldn't have been there in the first place."

Rima would like to raise awareness with this issue, as this not only has a negative impact on the environment but also on the judging criteria of the upcoming Vaka Pride event, as any rubbish which is wrongfully discarded could lead to a deduction of points. "It is simply an eyesore for the community, especially with the Vaka challenge just around the corner." Community leaders have a major role in this as well, with the necessary resources and personnel on hand.


Another area which is of concern to the Environment

Service is the littering of the Social Centre at Nikao. Rima mentions that people are placing their rubbish in plastic bags and tying them up on the nearby trees. "Not only is this bad for our beaches but it's also displeasing for the tourists to look at." Rima wants people to take their rubbish home upon leaving the premises and not leaving it as a problem for everyone else. "You aren't the only people out there who enjoy using the beach."

Rima would also like to encourage people to take on the Four R's initiative: Refuse, Reduce, Reuse and Recycle. "Everybody has a part to play because we are the caretakers of our environment."

## News Briefs PM Office Media releases

### PM Travel Brief

The Prime Minister is attending the Singapore Air Show and Aviation Leadership Summit 2016 and 2nd Pacific Islands States Transport Minister's Visit Programme – 14-17 February 2016. Included in the PM's programme is a dialogue with the President of the Council of ICAO. The PM is being accompanied by Transport Secretary Ned Howard and Airport Authority CEO Joe Ngamata. All the PM's travel costs, plus the delegation, are being met by the Singapore Government. The PM will depart Thursday and return the following week. A number of aviation issues are expected to be covered during the meetings, including those related to international airport requirements, and cooperation on standards and reporting.

### PM Muri Update

The Cabinet has expressed a priority to investigate the impacts of the proposed trial to scrape the lagoon floor to remove seaweed. Specifically, Cabinet wants to be satisfied there will be no adversity from the release of sulphides and other elements, which have built up in the sand sediment, and which is interacting with the weed growth. The experimental trial was not supported to proceed as planned for this week. Among the outstanding issues Cabinet wants attention to is compliance with waste treatment standards by various operators and entities. Health and Environment officials are expected to be more engaged with Muri land-based activities and management issues. The Prime Minister says he's supportive of government providing some help in the daily clean-up of seaweed from the beach areas, and will try and source suitable machinery.

### Response to Demo calls for DPM to stand down

The Prime Minister is not surprised that the Opposition is clutching at political straws to manufacture instability in the Government. Calls for the DPM to be stood down are being driven by a motive to disrupt at every opportunity. No removal action will be taken with respect to Heather's responsibilities because it is not warranted. The Prime Minister says there is no justification to suspend, and that any comparison to other topical cases is irrelevant.

# New generators will support renewable energy (RE) growth

**T**he Aponga Uira (TAU) is due to take delivery of five new generators soon, the first three to arrive on Monday 15th February 2016 and the remaining two a fortnight later.

The generators, which have a total capacity of 8,000kW, will strengthen the integrity of the Rarotonga power supply and are part of development plans to move towards a fully renewable-energy-based electricity system for Rarotonga.

CEO Apii Timoti said it may sound odd to take on new generators when the future is stacked differently: "Aren't we supposed to be investing in renewable energy only and no more diesels, people may ask?"

But Timoti said numerous challenges needed to be overcome before TAU reaches its full renewable goal.

"We will get there, but first we must go through a transition phase that not only involves installing RE systems but also integrating them with the existing network grid so the two systems work in unison.

"This is because PV (Photo

Voltaic) generation, or solar power as it is generally referred to, while the most abundant source for us, is highly variable and cannot be directly connected to the network grid".

Timoti explained the change meant TAU was going from a predictable system to one that is less predictable and much more complicated.

The existing infrastructure was designed and built for a conventional electrical system where the energy is not only produced at a single point then distributed to the users as required, but the production of the energy is constant and matched to the demand.

On the other hand, the solar production is not only highly variable, but its availability does not match the demand and these systems are scattered around the island. A

very complex control system is required to manage the distribution of the energy. In addition, the infrastructure needs the capability to cope with the fluctuating energy production, which will be achieved through a combination of methods,

including equipment upgrade or replacement, totally new control systems, and a reconfigured grid.

The changes cannot be done in one go and have to be implemented over time so as to avoid disruption to the electricity supply. Thus, the transition to the new system must be implemented in stages.

An important stage occurred in 2014 when TAU automated the controls of its existing fleet of engines which allowed the engines to respond faster. The installation of a full scale SCADA system provides advanced control capability. The improved stability of in the power system and additional capability to take on more PVs are attributed to these two developments.

The new generators have been chosen with Rarotonga's environment in mind. Not only are they fast responding engines, which cope better with the fluctuating PV generation. They are also fitted with computerised engine management systems, which further improve the capability to work with the PV systems and

the existing engines, enhancing stability and consequently increasing PV uptake. In addition, significant fuel savings are anticipated from these new generators due to their greater efficiency.

Most of the existing diesel engines are close to the end of their useful life. Engine driven generators will always be required as backup even for a 100% renewable grid, and the new engines can ultimately be run on biofuel in due course, so that they will be 'renewable' as well.

The next phase of TAU's development involves investment in storage systems.

Following pre-feasibility studies TAU has identified a number of options and is currently undertaking the associated detailed analysis into the various potential solutions. "Over the next four years we will see not only a dramatic increase in the number of PV systems on the island, but also additional infrastructure, which may include batteries, as storage", Timoti said.

# New data base will aid cyclone risk assessment

Cook Islanders can be put at ease this cyclone season, as a survey is currently being conducted in the outer islands with the purpose of collecting primary information for the Emergency Management Cook Islands (EMCI) geo-database. Head of EMCI, Charlie Carlson, spoke with the Herald on the importance of this survey.

According to Carlson, this survey was specifically designed to address disastrous management regarding how resilient people are against a tropical cyclone. This included inspecting the condition and type of housing (block or timber) as well as monitoring the water tanks. "With Mangaia, Mitiaro, Atiu

and Mauke we have a fair idea of what kind of housing they have," Carlson says. Based on what category a tropical cyclone will reach, EMCI can calculate the approximate percentage of how much damage will occur.


The secondary school students on the outer islands were the ones who conducted the survey, as part of their school project. They also assisted in entering the actual data into EMCI database. "A lot of work and effort was put into this," Carlson commented. "But it's good for the students, as they get a lot of practical work involving the tablets and other digital gadgets."

One problem that has arisen in the past is that after the data was collected and

collected, reports and assessments have gone missing. In order to prevent that from happening, all of the reports have been centralised onto the EMCI's geo-portal. "So, instead of ministries and other government agencies vying for one report, they can now focus on their own component."

Various boundaries have been divided in accordance to the surveyor. After the statistics have been displayed, EMCI can obtain a better understanding of the exact living conditions of the residents. "We now know the number of houses on some of the islands and which houses are occupied."

"It saves resources and time. Everybody will benefit."



# The test that can predict cancer 13 years before it develops

A test that can predict with 100 per cent accuracy whether someone will develop cancer up to 13 years in the future has been devised by scientists.

Harvard and Northwestern University discovered that tiny but significant changes took place in the body more than a decade before cancer was diagnosed. Protective caps on the ends of chromosomes, which prevent DNA damage, had significantly more wear and tear in those who went on to develop cancer. In fact, they looked like they belonged to a person who was 15 years older.

The caps, known as telomeres,

were much shorter than they should have been and continued to get shorter until around four years before the cancer developed, when they suddenly stopped shrinking.

"Understanding this pattern of telomere growth may mean it can be a predictive biomarker for cancer," said Dr Lifang Hou, the lead study author and a professor of preventive medicine at Northwestern University.

"Because we saw a strong relationship in the pattern across a wide variety of cancers, with the right testing these procedures could be used eventually to diagnose a wide variety of cancers."

Although many people may

not wish to know that they will develop cancer in the future, it could allow them to make lifestyle changes to lower their risk. Stanford University is also looking at how telomeres can be re-grown.

Insurance companies warned that such a test could push up policy premiums.

Matt Sanders, who is in charge of protection insurance products at GoCompare, said people with such a diagnosis could be priced out of the insurance market. "If this test showed 100 per cent probability over a certain number of years then it could affect premiums. It would be the equivalent of living in a high theft area for someone looking for home insurance," he

said.

In the new study, scientists took multiple measurements of telomeres over a 13-year period in 792 people, 135 of whom were eventually diagnosed with different types of cancer, including prostate, skin, lung and leukaemia. Initially, scientists discovered that telomeres had aged much faster in individuals who were unwittingly developing cancer. But then they found the accelerated ageing process stopped three to four years before the cancer diagnosis. "We found cancer has hijacked the telomere shortening in order to flourish in the body," said Dr Hou.

The research was published in the online journal *Ebiomedicine*.

# Ian George, the artist's artist

Cook Islands artist Ian George recently passed away at his Rotorua home in New Zealand on after a long illness. He will be greatly missed by the local art community and his contribution to Cook Islands art will be remembered and commented on for many years to come.

Over the years, Ian and I spent quite a bit of time in his workshop at his home talking about the future direction of Cook Islands art.

It was my argument that Cook Islands art should develop its own identity which would make our art form readily identifiable as Cook Islands art.

Ian favoured a regional approach. He believed we should firstly develop our art along with artists from the Pacific Region in order to attract international attention to the Pacific.

I urged Ian to develop a curriculum for Tereora College art students on Cook Islands art forms as a means to preserve the culture. He resisted this for a long while but eventually produced a draft curriculum which went on to be introduced.

Through their first then current gallery the Art Studio in Arorangi, Ian and Kay supported many local established and emerging artists. Pitt Media reported on many of the exhibitions held there. They also hosted a



number of prominent overseas artists and exhibited their work. As an artist and a person, Ian was

greatly respected.

While Ian always struck me as a bit of an academic, a very

focused and disciplined artist, I think he was the closest we had to an "artist's artist."

# The Kay and Ian show

The recent art exhibition at Ian and Kay George's art gallery, "The Art Studio," in Arorangi was significant in that it marked the first occasion both artists have exhibited together.

Kay advised the Herald on Tuesday morning that it had been a very successful show. It was well attended and some 20 pieces were snapped up mainly by locals. Only a few pieces still remain and are available for sale.


This show differed from others held at the Art Studio in that Ian and Kay wanted to do something different. The exhibition had a bit of everything. The works were affordable and most were of a size easy to pack for travel. Kay said people are still buying art but are more discernable and she has found that the textile pieces work well mainly because they are easy to transport.

Kay said that in September/October the Art Studio plans to hold an outdoor exhibition, behind the gallery, of sculptures. She plans to talk to other artists about the concept.

In early June an exhibition of graffiti works is planned involving graffiti artist Nathan Welsh and local artist Mata Priest.

In the gallery at present is a diverse range of works by Ian and Kay and there are also some recent canvases by Mahiriki Tangaroa.

Kay has always kept her work fresh and has not been afraid to experiment with new forms, materials and concepts. Her works include painted furniture and large floor tiles. She has recently begun laying images on small pieces of stainless steel. It presents a different visual effect.



# Bob n' Slay and Tons of Skelly

The organizers of the World Bobsleigh and Skeleton Championships are flat out advertising the chilliest championships in the world.

The event is already on and it lasts till the 21st February and I am sure everyone is having a very good time.

But there's a problem for those of us living in a hot country.

What on earth are the sports in question all about?.

How exactly do you "slay a bob" and why do need "tons of skelly" to do it?

**BACKGROUND**

Good questions.

There's no one in the Pacific who plays them so it's hard to explain.

So, how do you go about describing sports played on very high mountains in very cold conditions which seem to be a unique way of committing suicide?

Perhaps the best way of explaining what's going on, is to take a sport we all know well in hot countries.

I refer to a popular local pastime, played daily with dedicated casualty.

It calls for the same amount of casual speed round corners, more causal speed round the next corner, followed by casual cutting in at incredible amounts of casual speed on

bends with white lines down the middle.

Here it's known as "driving".

It's the local equivalent of bobsleigh and skeleton.

It gives you a similar chance of checking out living conditions on the other side, known as "the after-life".

**EXAMPLE**

You know the last downhill bend on Rangimotia when you're heading for the taro patch.

There's a bit where you practice dodging the bloke who's just passed your bike flat out on the way up.

You execute a defiant flat out dazzling death-wish with a final screech of the brakes and a brilliant last second flick to the left or right hand side of the track and narrowly avoid taking off for the reef five hundred feet below?

Got it?

Right!

Now, imagine, by chance, the same venue after a ferocious snowfall the night before during a sudden attack of climate change..

Picture the long sheet of solid ice which covers all traces of traces of track to assist in executing your death defying manoeuvres.

That's what you "slay the bob" on....

Then, imagine doing it at over

90 mph. face down with your nose two inches above the ice and no brakes.

If they want to go shopping in the village in the valley, four of them mount a bob, select a driver and set off down the mountain.

If it's getting late and the shops are due to shut in just over one minute's time, one of them flings himself on skelly face down, sets off at about 100 mph and hopes the shops will stay open an extra minute.

I'm joking, of course. The shops in mountain villages always shut in less than one minute's time.

So, why do bobsleighters and skeletonians do it?

Personally, I've no idea, as I live in a very warm country.

**IGGLES**

I know, however, that they are doing it for the next two weeks in a place called Iglis, pronounced, I presume, as "iggles",

I know because of the advertisers.

It's near Innsbruck in Austria.

It is currently "a place of pilgrimage for international bobsleigh and skeleton fans."

The track is described as "a ribbon of concrete steel and ice".

It zig-zags all the way down the mountainside.

280 competitors are taking part, assembled from 28 nations on one of the world's toughest tracks.

That's roughly the same number as those who have negotiated Rangimotia downhill on a bike between 8.00 a.m. and 8.01 a.m. each morning

The advertisers recommend the "fierce and thrilling competitions for all fans and spectators" who survive the opening day. They provide buses and shuttles for all those who continue to survive.

**COMPETITION**

Who will be crowned world champion?

The decision will be made here, say the advertisers, "as the athletes race down the ice track and fight for every thousandth of a second".

They urge you to experience for yourself the speed, adrenaline and pounding hearts that shape these two sports.

And more than that, if you'd like to have a go yourself, you can try speeding down the ice track like the pros, accompanied by at least one professional each time.

If you're nuts!

And if you know how to zig-zag it home though the speed, adrenaline and pounding heat that shape a late-night ride down Rangimotia!

# How to live with integrity

In Part 1 I noted that there are people around us who are always watching how we behave, to see what kind of a person we are especially when we are Christians or believers in the Lord Jesus Christ. In I Peter 2v.12 it reads "People who do not believe are living all around you. Live such good lives that they will see the good things you do and will give glory to God." People watch to see if we have integrity - meaning Honesty, Truthfulness, Reliability. Peter says that there are 3 things that test our INTEGRITY: (1) TEMPTATION,

- (2) AUTHORITY,
- (3) SUFFERING.

How we respond to these 3 things will determine whether we are good witnesses for God or not, and whether we have integrity or not. The main Bible reading is I Peter 2v.11-25. In this passage Peter is saying, in living with INTEGRITY we need to do 3 things:

- 1) Stay away from TEMPTATION;
- 2) Show respect for those in AUTHORITY and;
- 3) Seek God in our SUFFERING.

### 1). STAY AWAY FROM TEMPTATION

As Born Again Christians we are free. We can't lose our salvation. But we shouldn't use that as an excuse to sin. Because integrity demands that we don't do what is not right in the sight of God. In I Peter 2v.15 it reads "It is God's will that your good lives silence those who foolishly condemn the Gospel without knowing what it can do for them, having never

experienced its power." God's will for our life is that we live with integrity, that our life matches what we say we believe.

### 2). SUBMIT TO THOSE IN AUTHORITY FOR THE LORD'S SAKE

Our integrity is tested on how we respond to authority -- people in government, our boss, spiritual authorities like Pastors, and so on. v.14 in our reading reads "For the Lord's sake yield to the people who have authority in this world..." Those in authority are ordained by God. What if the Government tells me to disobey God? Obviously your first allegiance is to God. Submission sometimes means being willing to suffer the penalty for doing the right thing. If there's a law that says "Do this" and you know it's wrong, God says it's wrong.

If you don't obey that law, submission means at that point 'being willing to suffer for doing the right thing'. Your Boss at work is in a place of authority over you. The Bible says that you are to submit and respect your employer (boss). "But you don't know my boss!" Doesn't matter, v.18 reads "Be good servants to your masters -- not only to good masters, but also to bad ones." How's your attitude at work? Does it show your integrity? Do you quietly and gently just accept things that happen or do you complain like everybody else?

### 3). INTEGRITY IN SUFFERING

The greatest test of all will be our response to Suffering. Nothing reveals our character quicker than



problems and pain. That is one of the reasons why God allows it. When you go through suffering it really reveals what you are like. People are like tea bags; you don't know what they're like inside until you put them in hot water. We will always have problems. Fortunately, God gave us a model of how to handle that Suffering with Integrity. v.21 reads "This is the kind of life you've been invited to, the kind of life Christ lived. He suffered everything that came His way so you would know that it

could be done, and also how to do it, step by step." Jesus is our model of how to handle suffering, particularly when we're mistreated unjustly.

Remember that people are watching us to see How We Respond to TEMPTATION, to AUTHORITY, and to SUFFERING. Jesus said, "You are the salt of the earth...you are the light of the world...Let your light shine before men, that they may see your good works and praise your Father who is in heaven."

May you have a God blessed week – te Atua te aroa.
